Location

Kensington Square is situated in the north district of Burnaby at Hastings Street, between Kensington & Grove Avenue. Kensington Square is connected by/ accessed by a six-lane major east to west thoroughfare linking downtown Vancouver to the west and Port Moody and Coquitlam to the east.

Kensington Square is an open community shopping centre consisting of four separate buildings with a total net rentable area of 120,500 SF. Anchored by Safeway, and with tenants such as a Shoppers Drug Mart, Royal Bank, Starbucks, Cobs Bread, Petro Canada and Dairy Queen, Kensington Square is the dominant shopping complex in North Burnaby.
