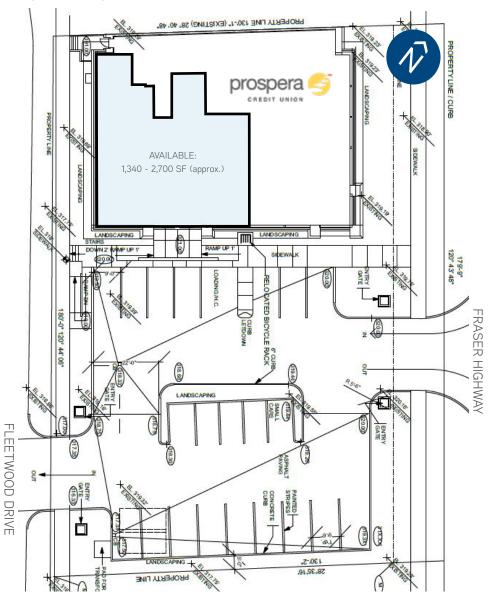
OPTION 1 (ONE UNIT)

LOCATION

15288 Fraser Highway is located in the Fleetwood area of Surrey amongst the area's most prominent shopping centres.

- > High traffic location just east of 152nd Street
- Save on Foods, Safeway, No Frills Grocery Store, Prospera Credit Union, Envision Credit Union, She's Fit, Dollar Max and Shopper's Drug Mart are in close proximity
- > Prominent location on the Fraser Highway. Fraser Highway is a major east/west arterial that connects Langley and Abbotsford to Surrey's City Centre
- > Fleetwood boasts a population in excess of 62,735 persons and an average household income of \$97,637 (2016 Census).



PROJECT

The building comprises over 5,500 SF of rentable area anchored by Prospera Credit Union who has occupied the building for approximately 20 years. Prospera Credit Union is in process of renovation and "right-sizing" their space. As a result, up to 2,500 SF (approx.) is available to lease.

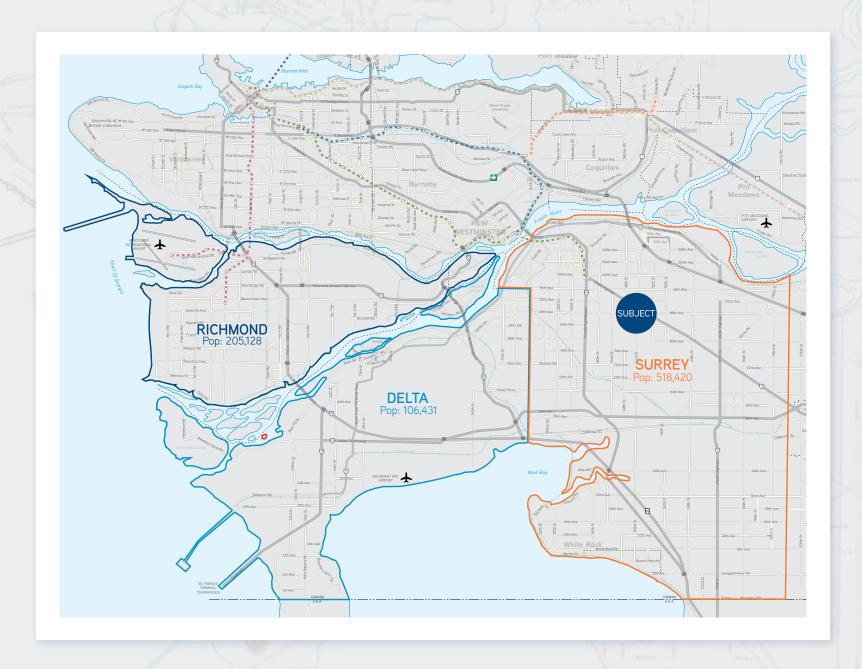
