























# **Building Features**


Pacific Surf Apartments is a 22-storey, waterfront, concrete apartment building featuring a total of 119 residential rental units, with 54 units having undergone recent renovations. The Property offers both secured underground and surface parking. The underground parking structure comprises two floors, providing a total of 59 parking stalls and 5 motorcycle stalls, while the surface parking lot accommodates an additional 41 parking stalls. Amenities include an indoor pool, sauna, gym, changing rooms with tenant storage lockers, and bicycle storage.






