Location

A separate section of the warehouse includes includes a deionized water system, a production area consisting of six (6) enclosed rooms with epoxy floors, water stations, floor drains, and FRP (fiberglass reinforced panel) walls. This area is conditioned for use in the production of vitamins and supplements for animals and for dry storage. A restroom and shop office are located within the warehouse.

The office area consists of a large showroom/reception area, conference room, coffee room, 3 private offices, an IT/storage room and a large lab or open area and 2 restrooms.

Floor Plan


