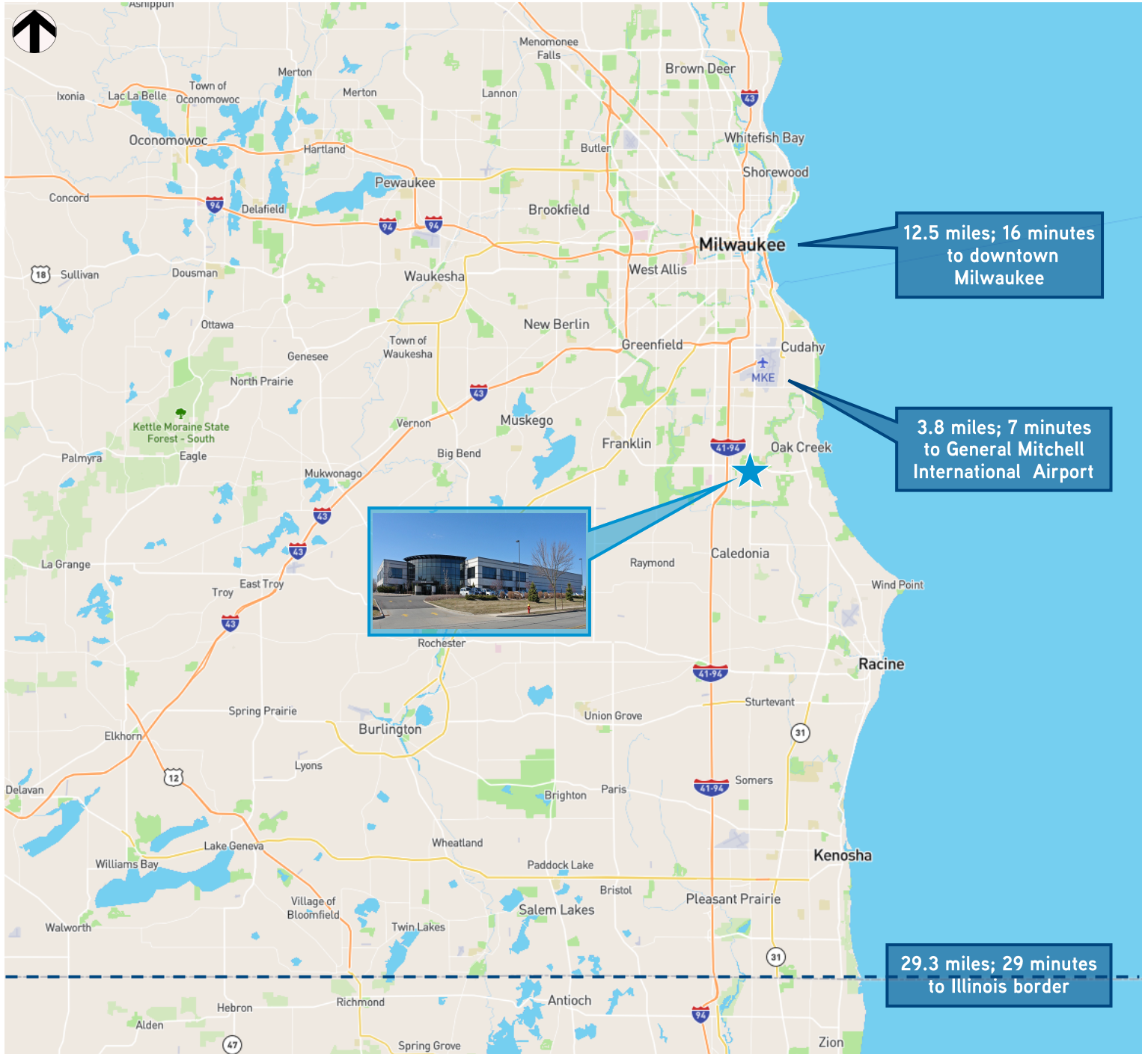

## Location Map



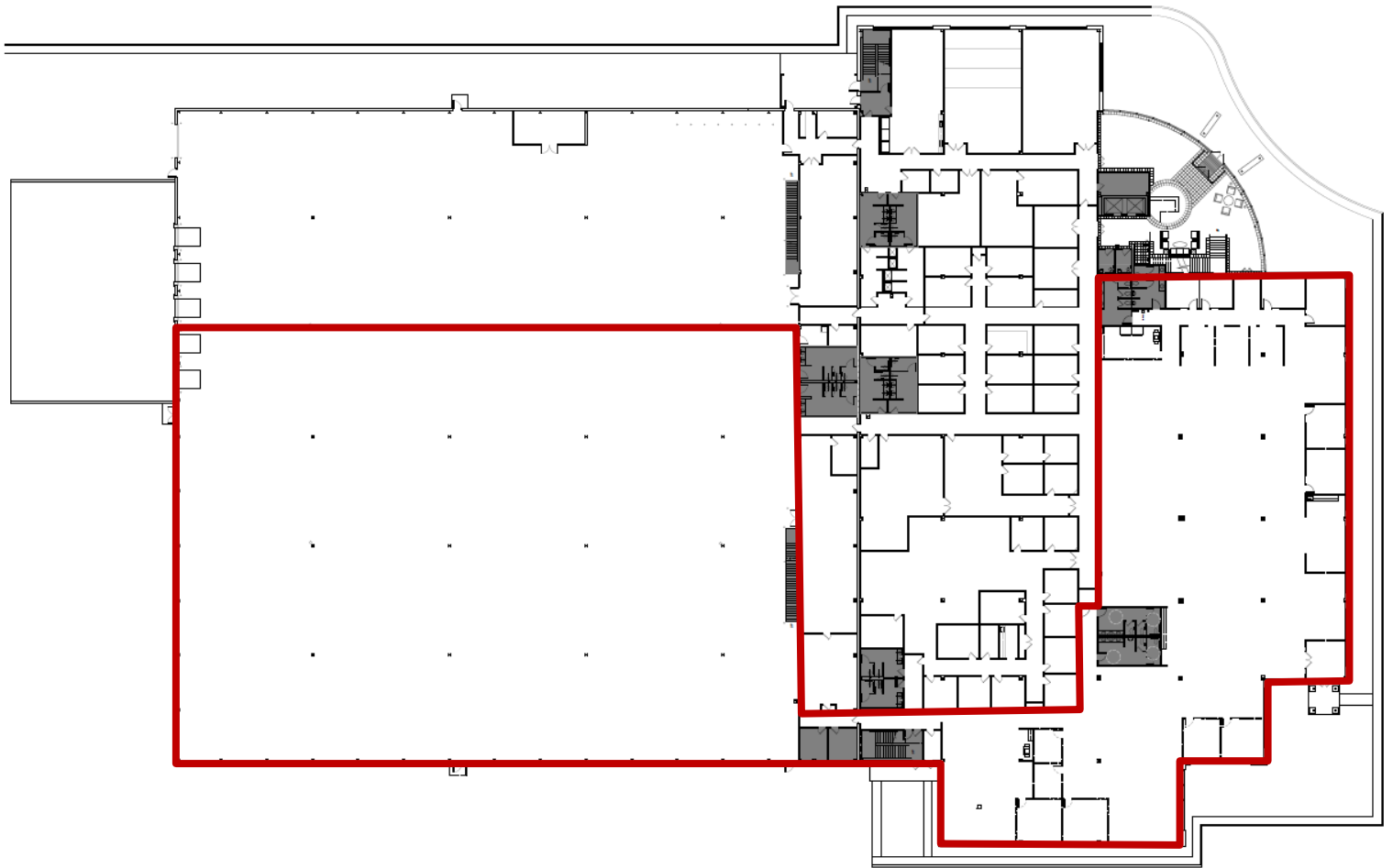

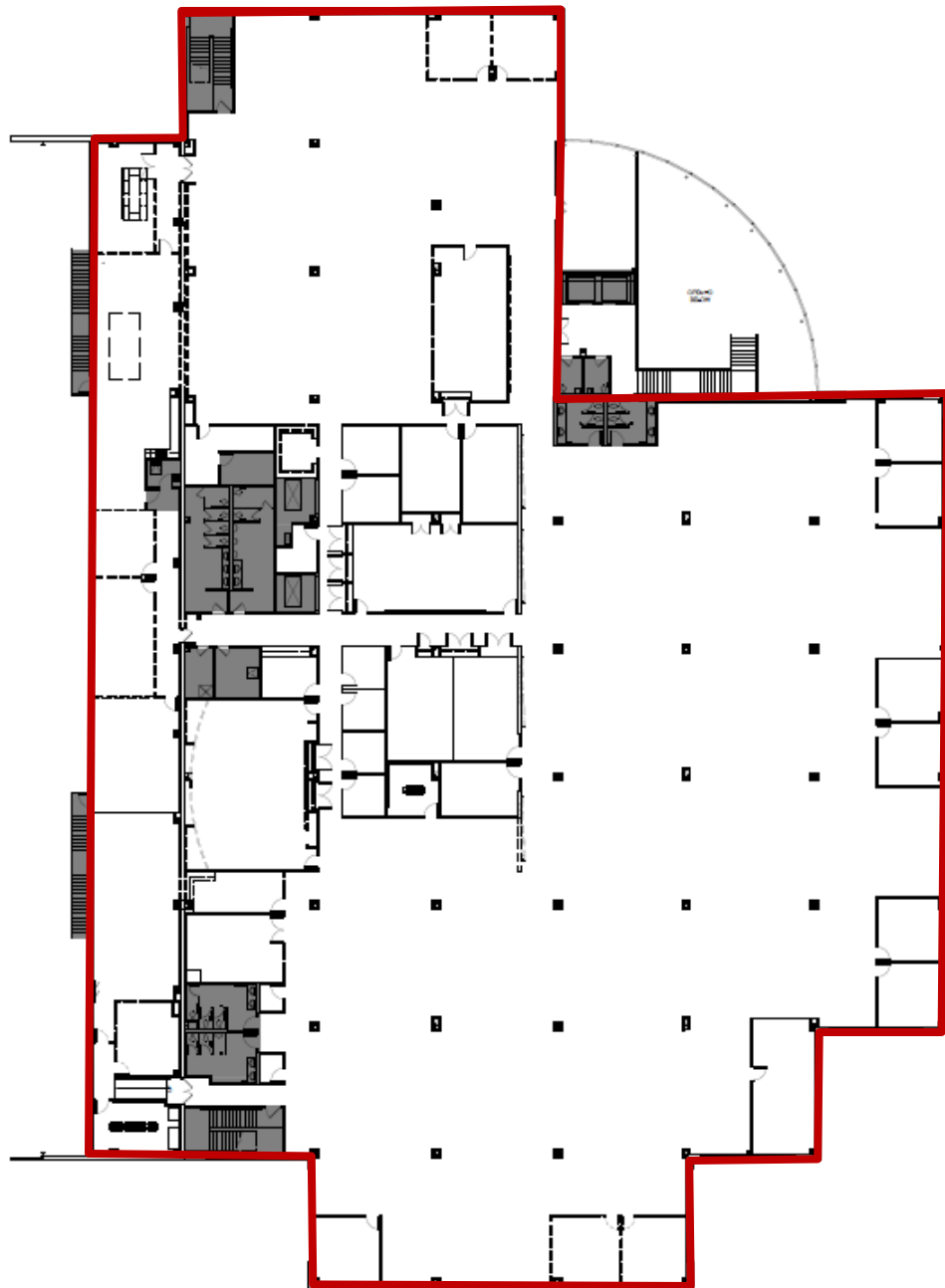

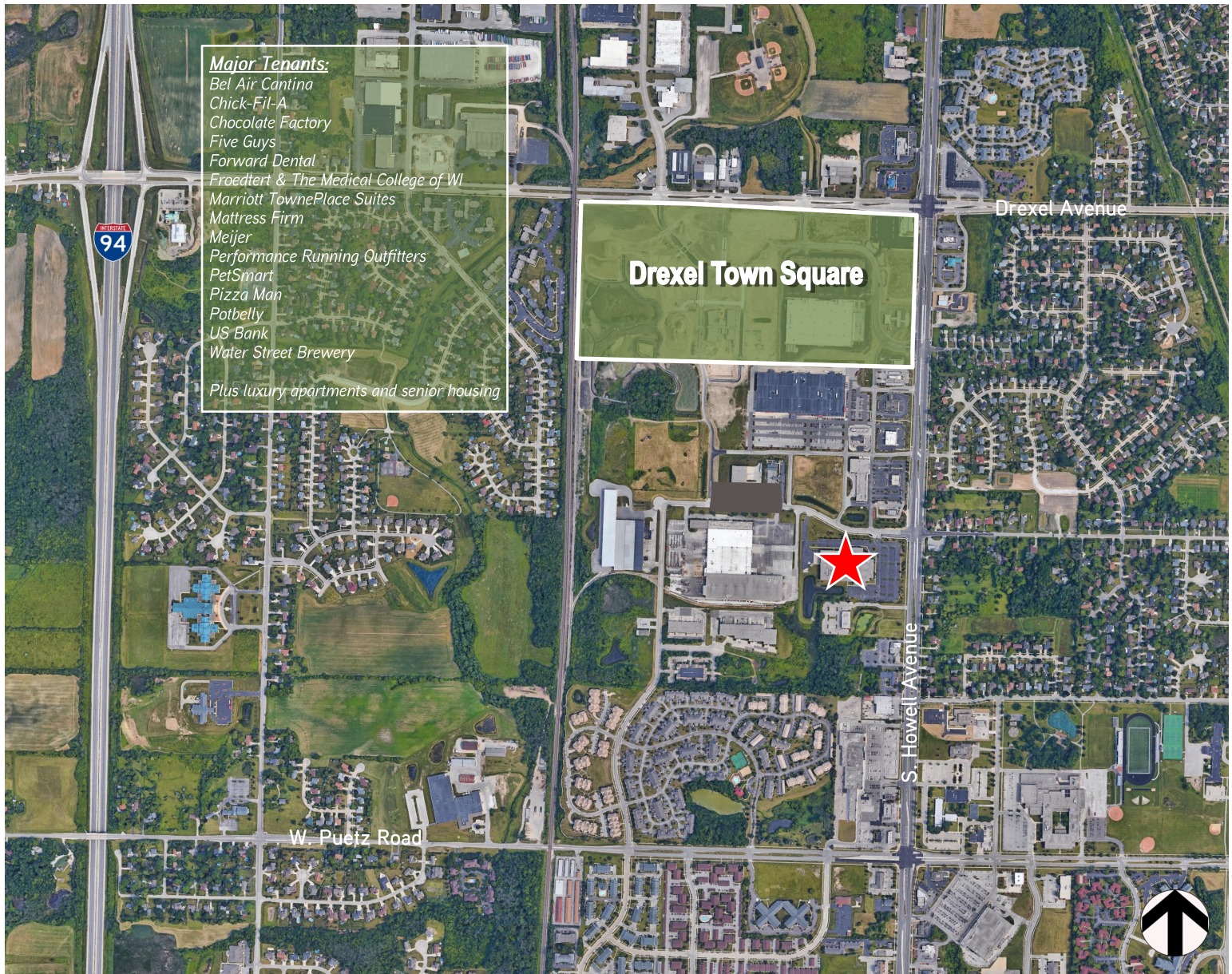
