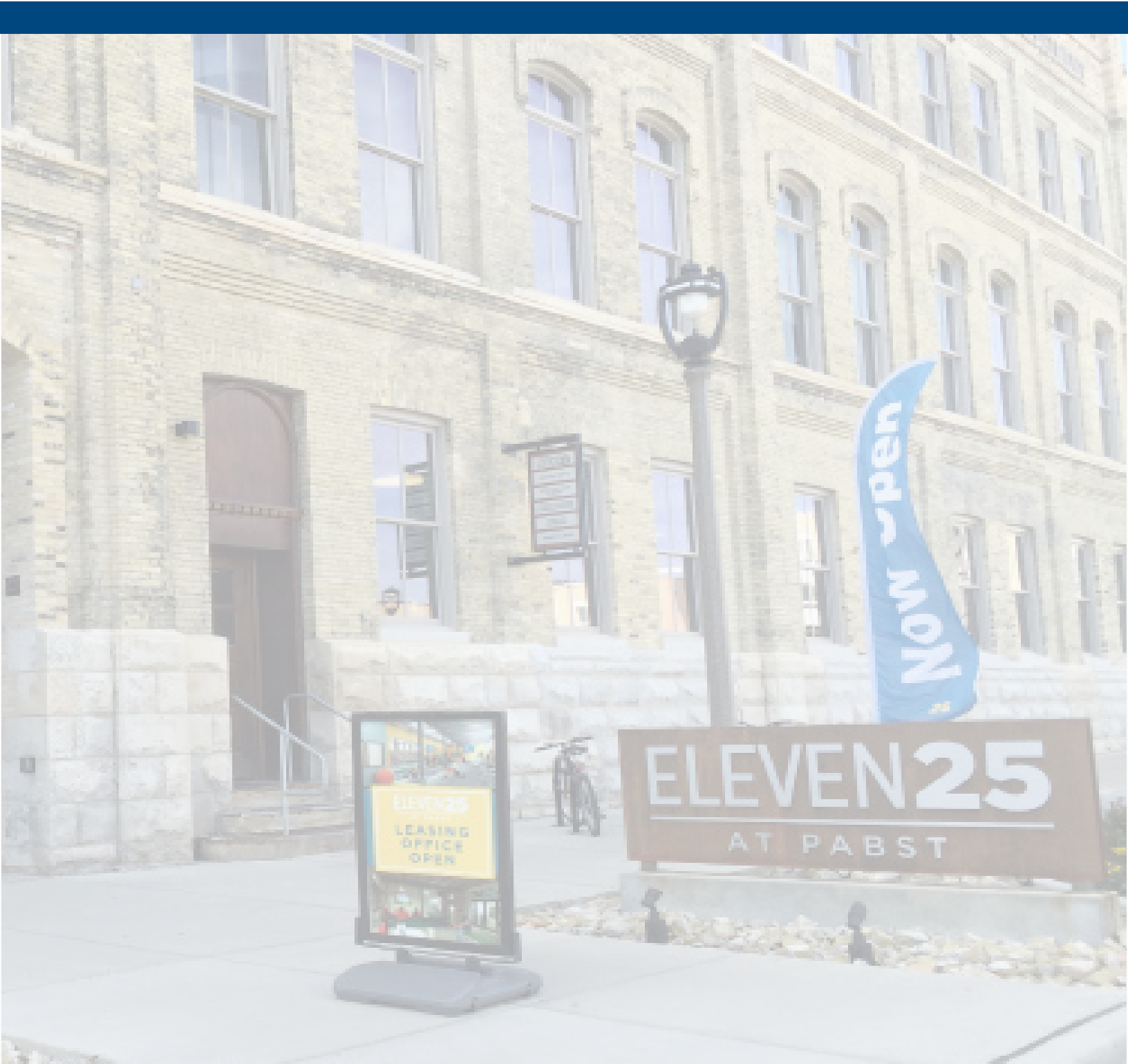

BROKER DISCLOSURE TO NON-RESIDENTIAL CUSTOMERS

An "adverse fact" is defined in Wis.
