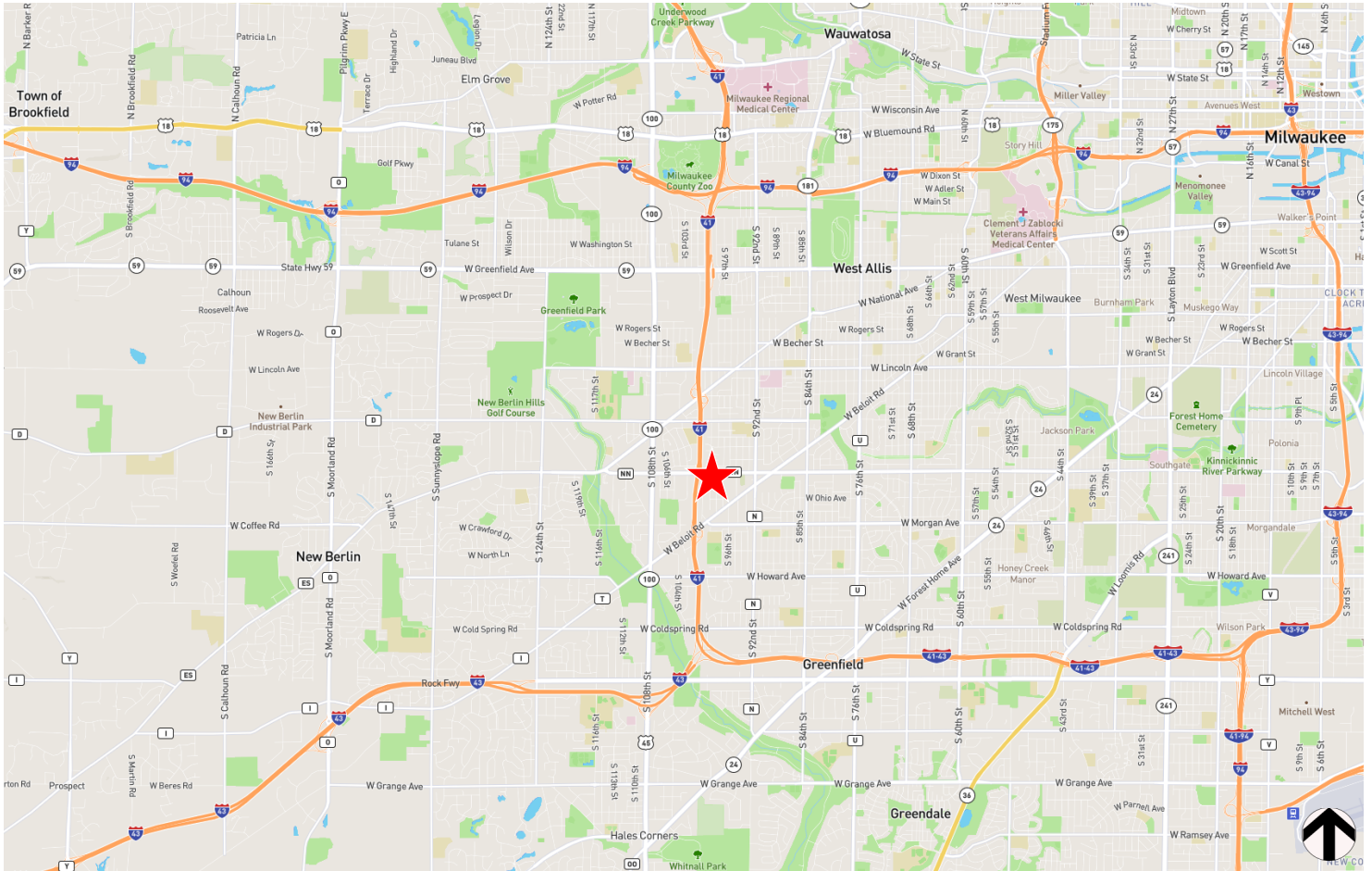

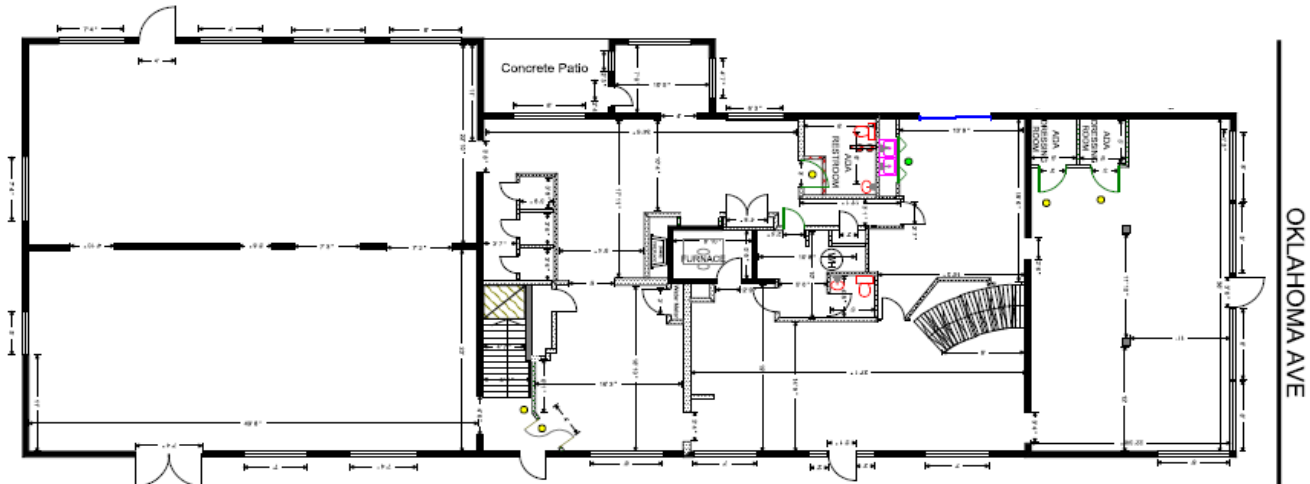

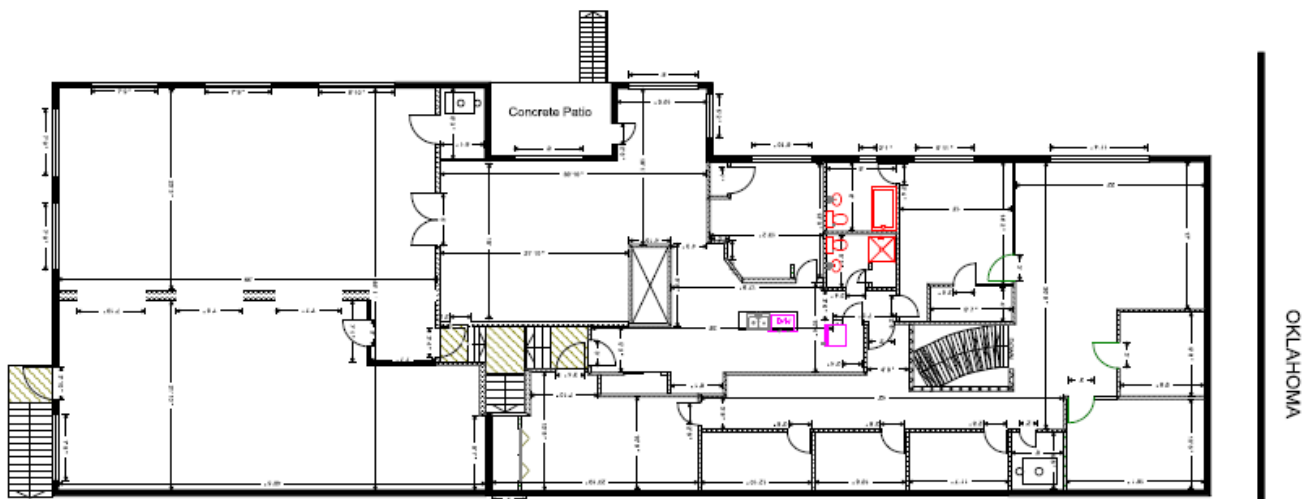

First Floor Layout



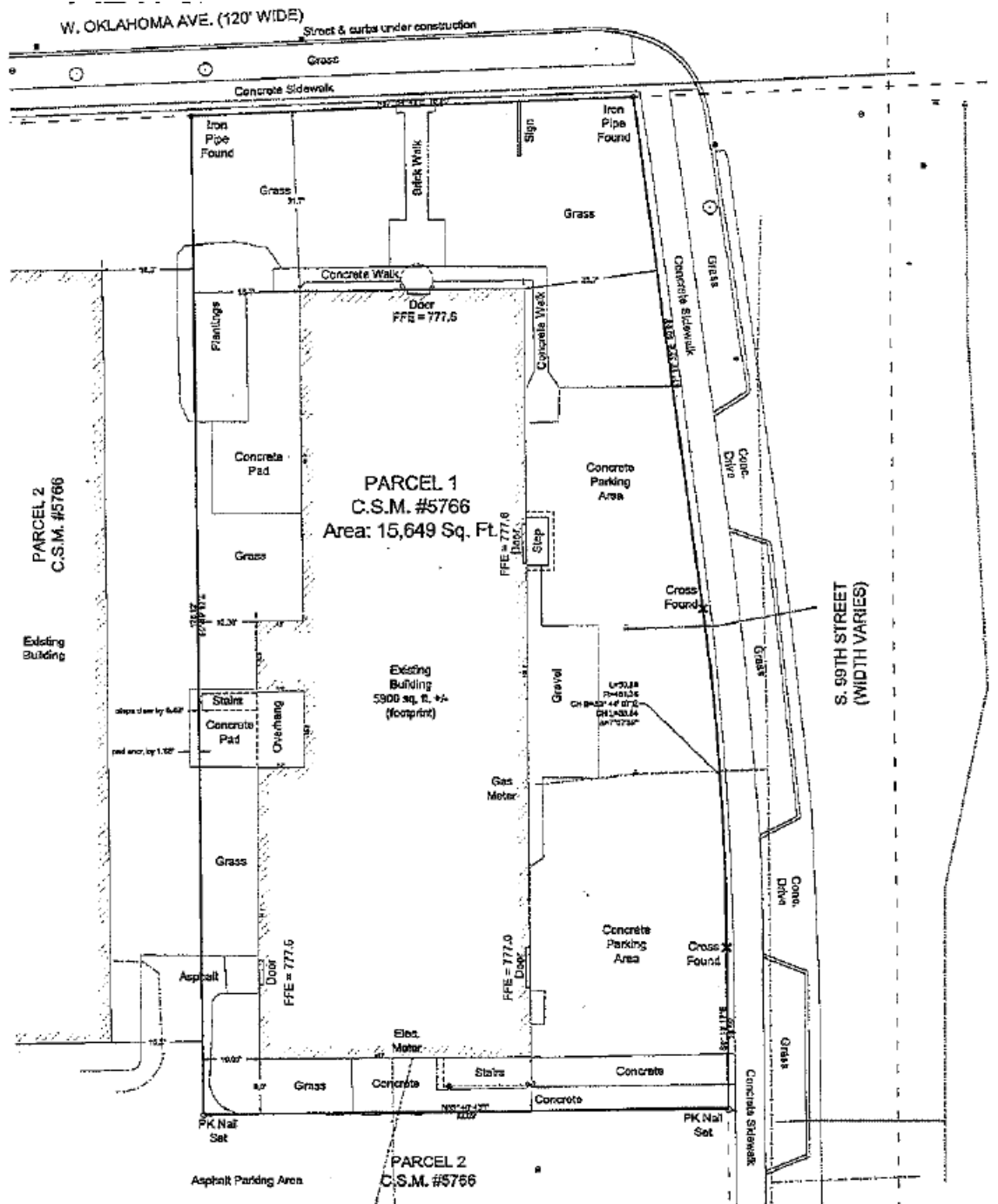
Second Floor Layout

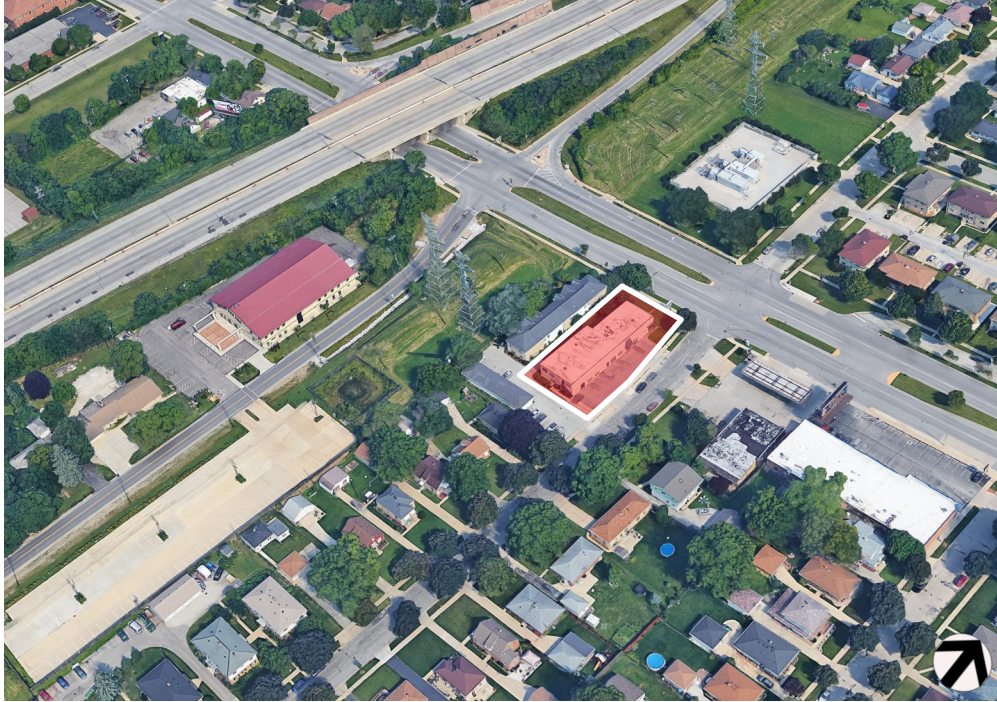

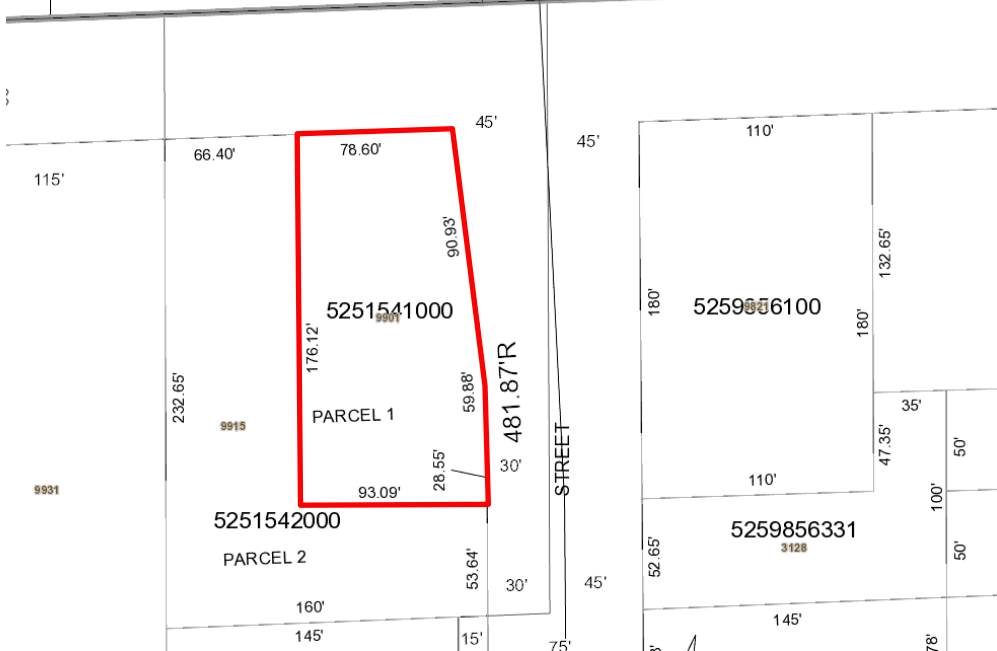
