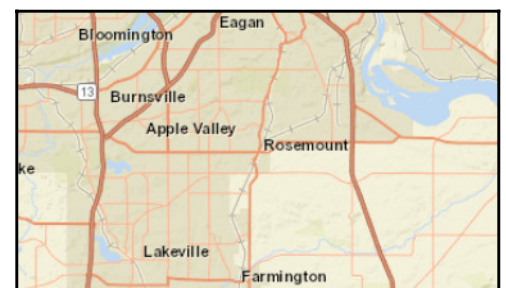
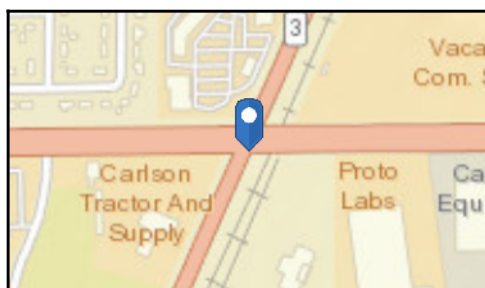
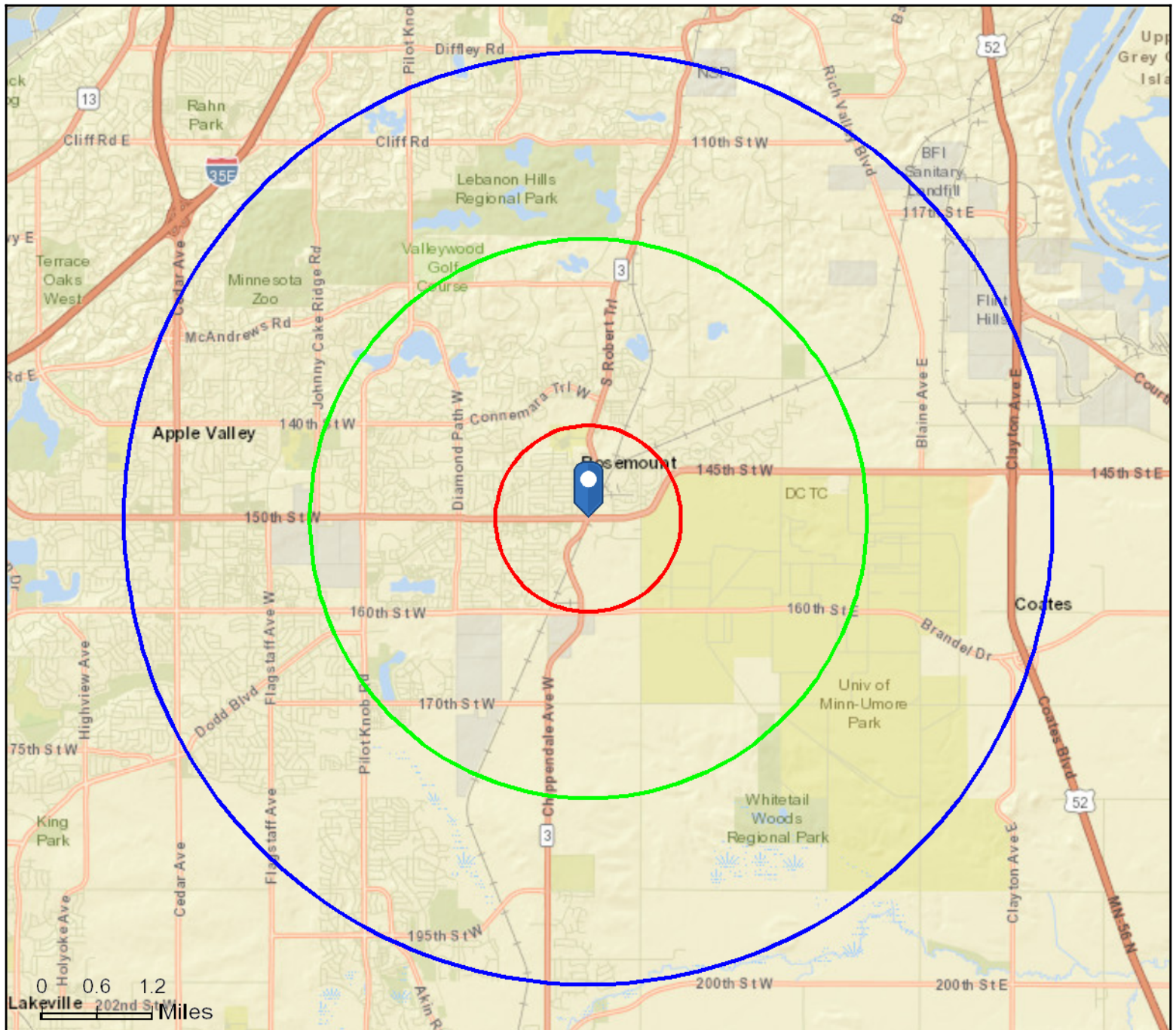

Currently, 83.9% of the 39,681 housing units in the area are owner occupied; 13.7%, renter occupied; and 2.4% are vacant. Currently, in the U.S., 55.6% of the housing units in the area are owner occupied; 33.1% are renter occupied; and 11.3% are vacant. In 2010, there were 36,989 housing units in the area - 83.9% owner occupied, 12.6% renter occupied, and 3.5% vacant. The annual rate of change in housing units since 2010 is 3.17%.
