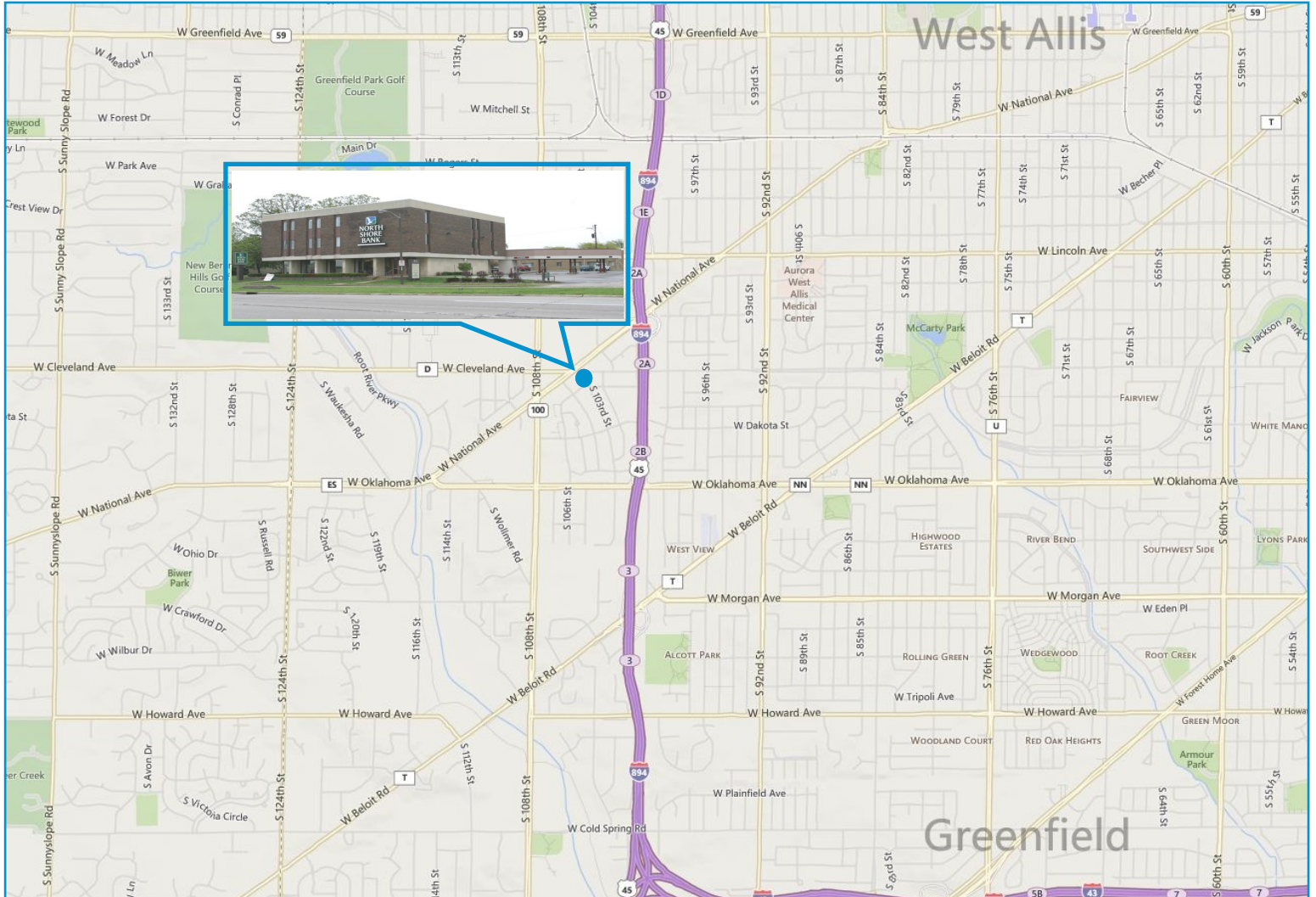

## Location Map

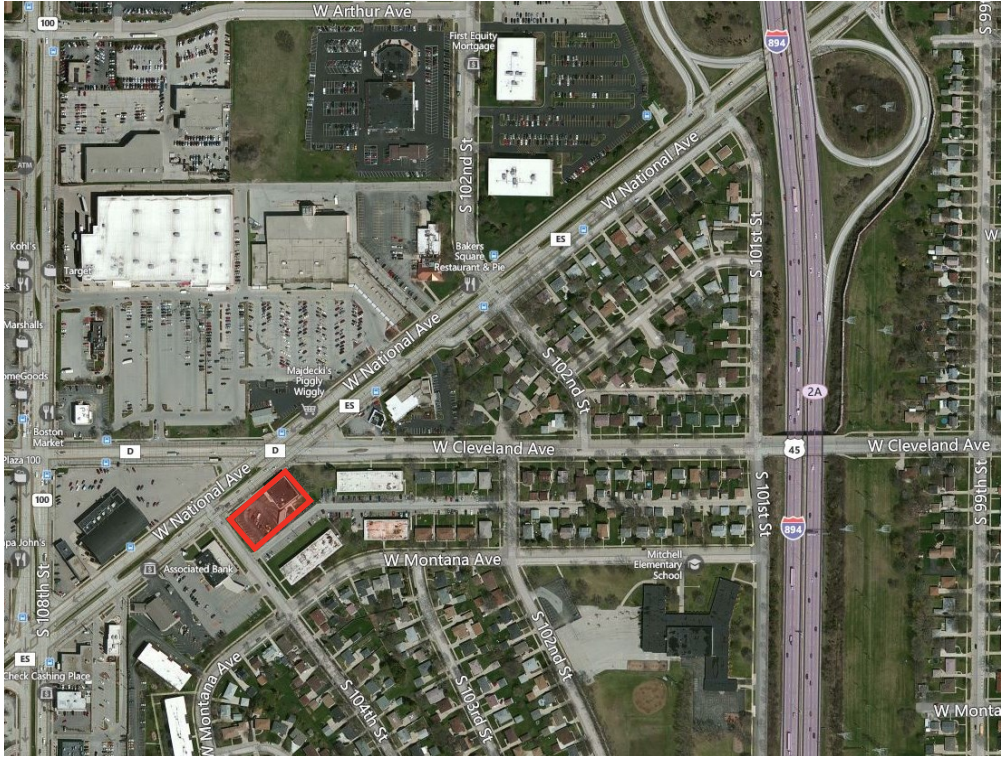
