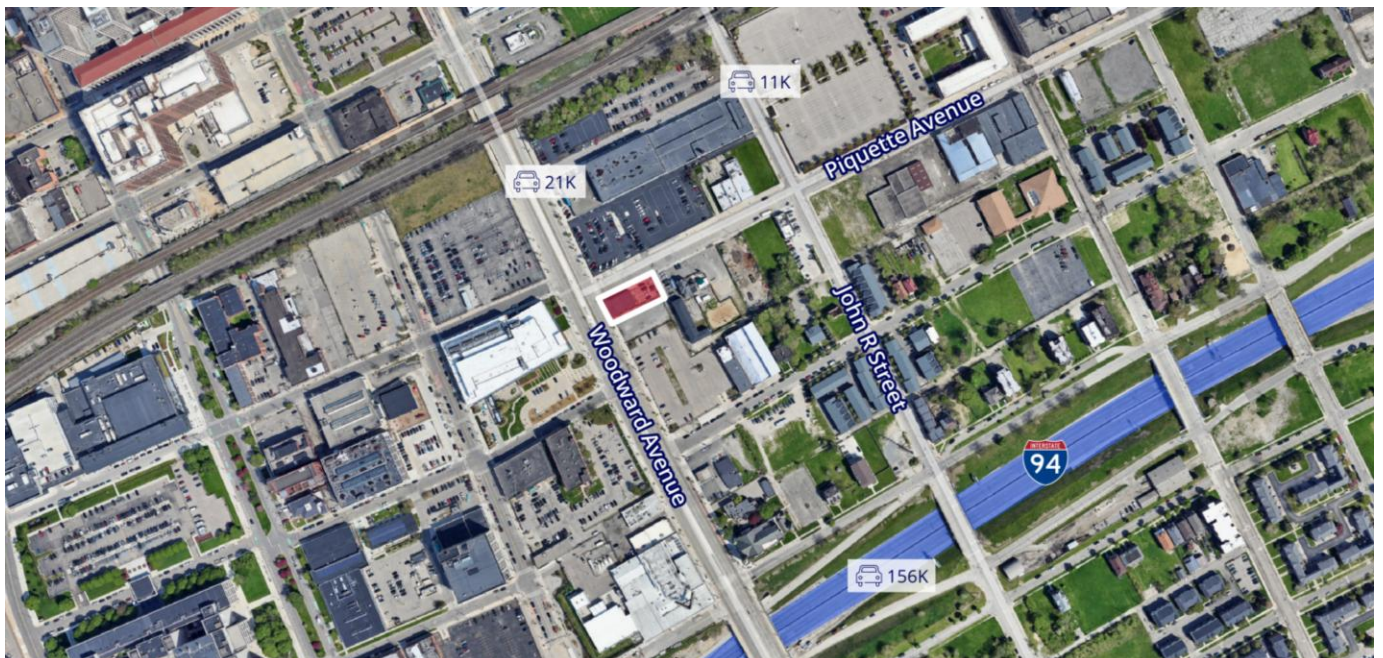

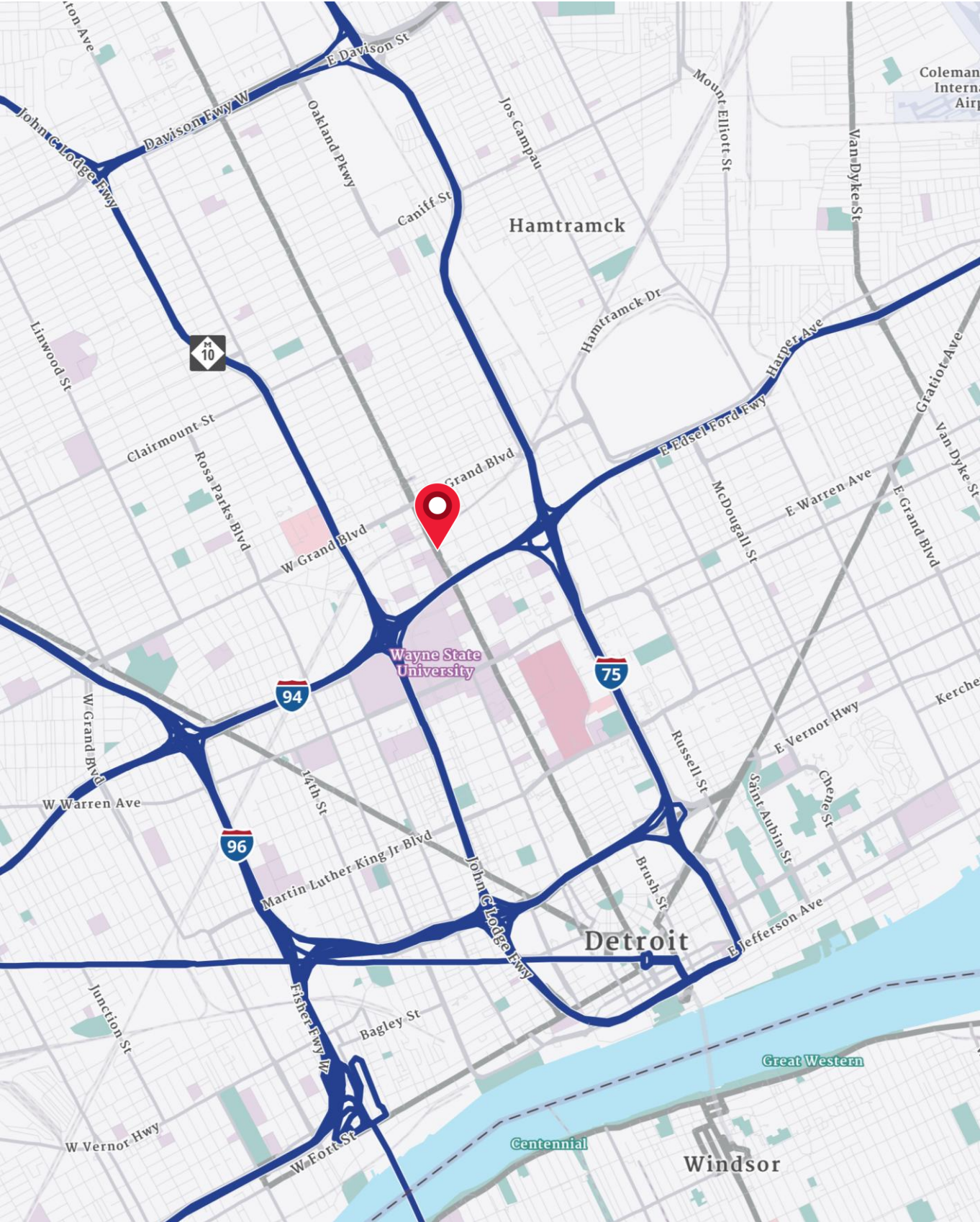
Rendering and Property Aerial
