







Flex Market

Vacancy rate for flex product is now at 9.8% for the overall market, which is the first time in single digits in more than a decade. The vacancy rate for flex product in the southwest submarket fell by 5.5 percentage points to 13.3% over the last 12 months. As the inventory has contracted, the asking rents have increased 6.7% year-over-year.
