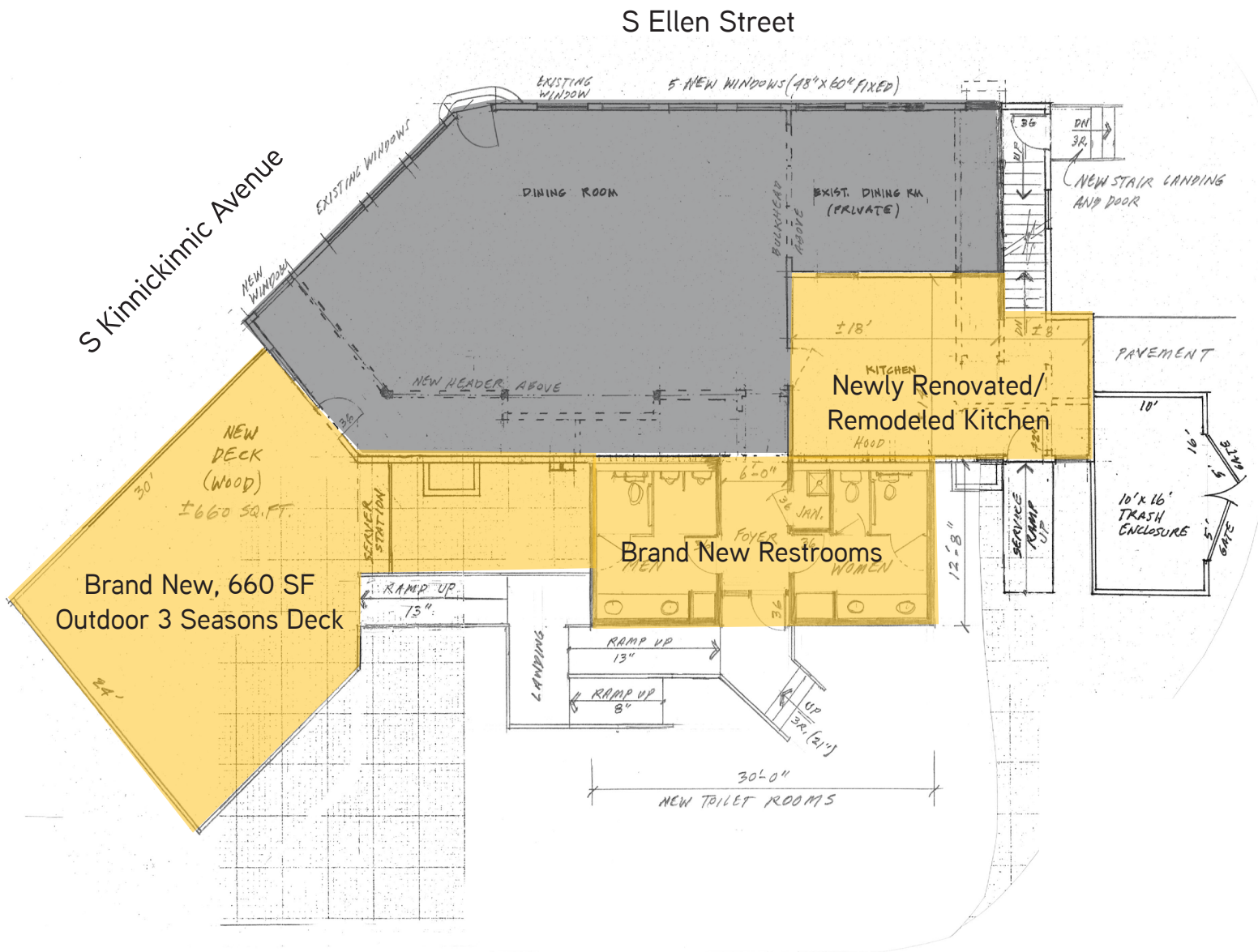

## First Floor Plan

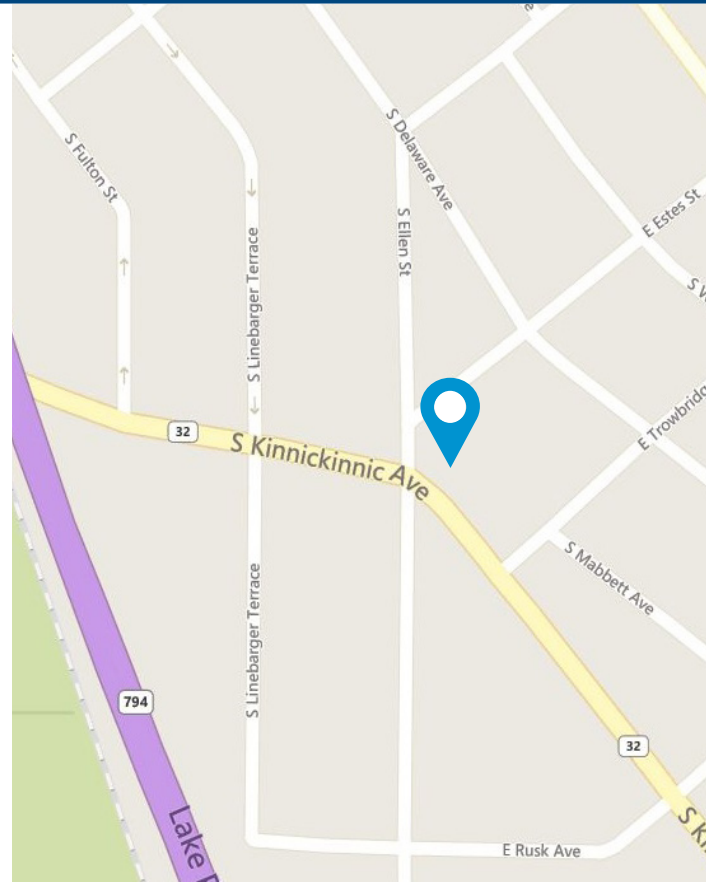
