

Currently, 65.1% of the 93,210 housing units in the area are owner occupied; 29.2%, renter occupied; and 5.7% are vacant. Currently, in the U.S., 55.7% of the housing units in the area are owner occupied; 32.8% are renter occupied; and 11.6% are vacant. In 2010, there were 89,755 housing units in the area - 65.0% owner occupied, 29.2% renter occupied, and 5.9% vacant. The annual rate of change in housing units since 2010 is 1.69%. Median home value in the area is \$233,191, compared to a median home value of \$200,006 for the U.S. In five years, median value is projected to change by 3.29% annually to \$274,166.






2015 Household Income






2015 Household Income






2015 Household Income
