Location Map



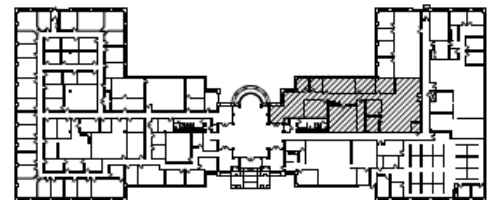
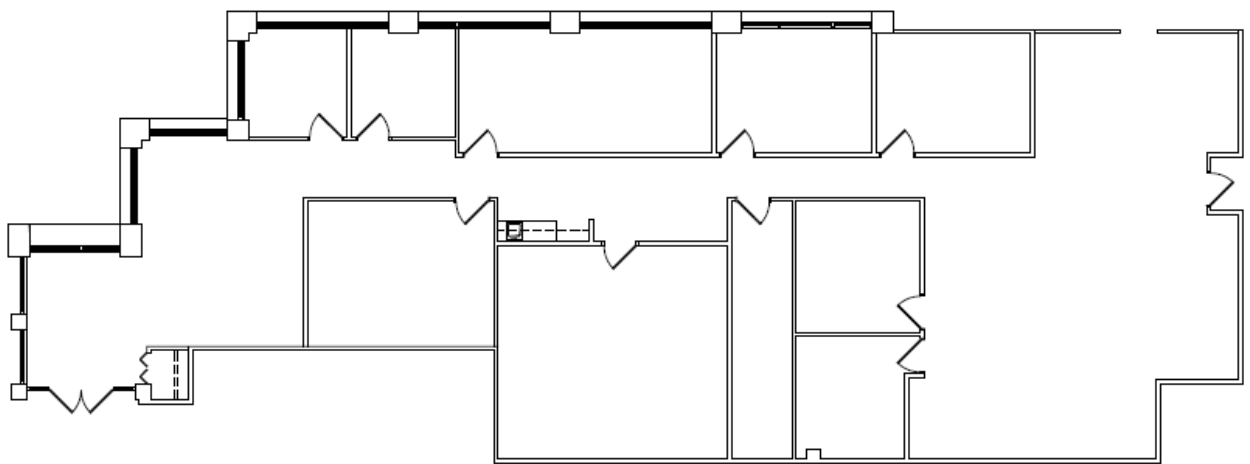

SUITE 150: 4,332 SF (CONTIGUOUS TO 6,470 SF WITH SUITE 190)



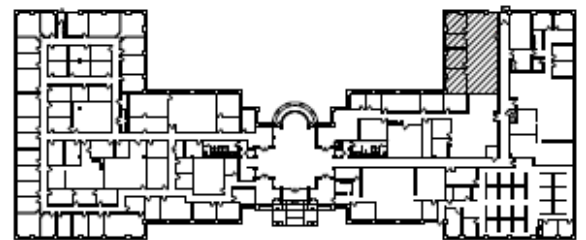
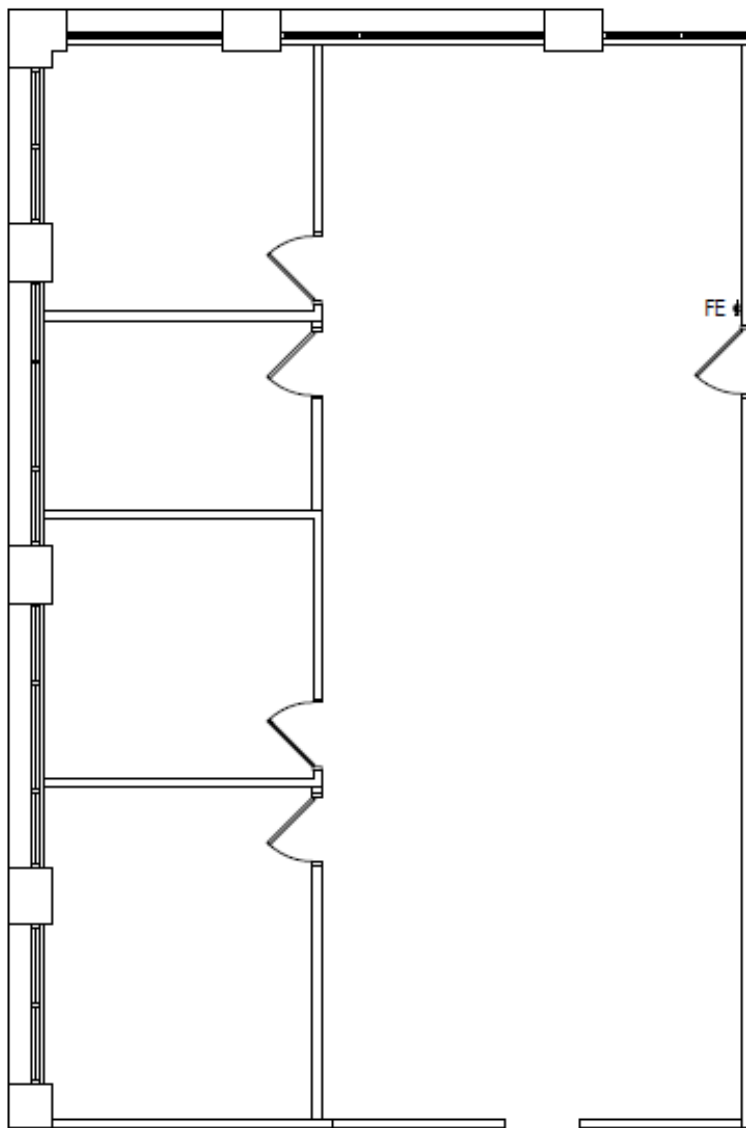

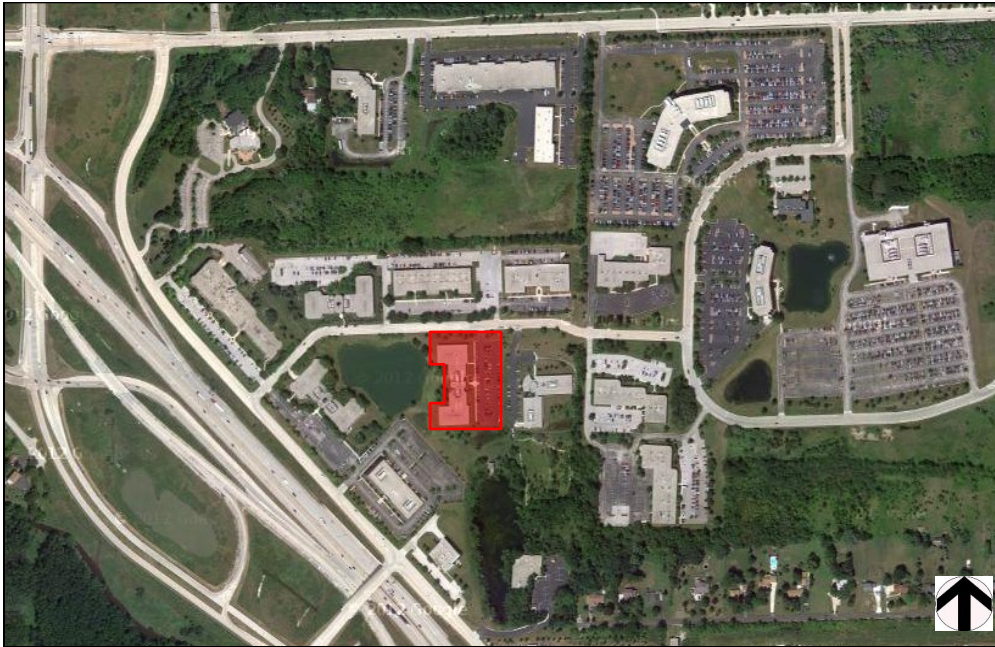
