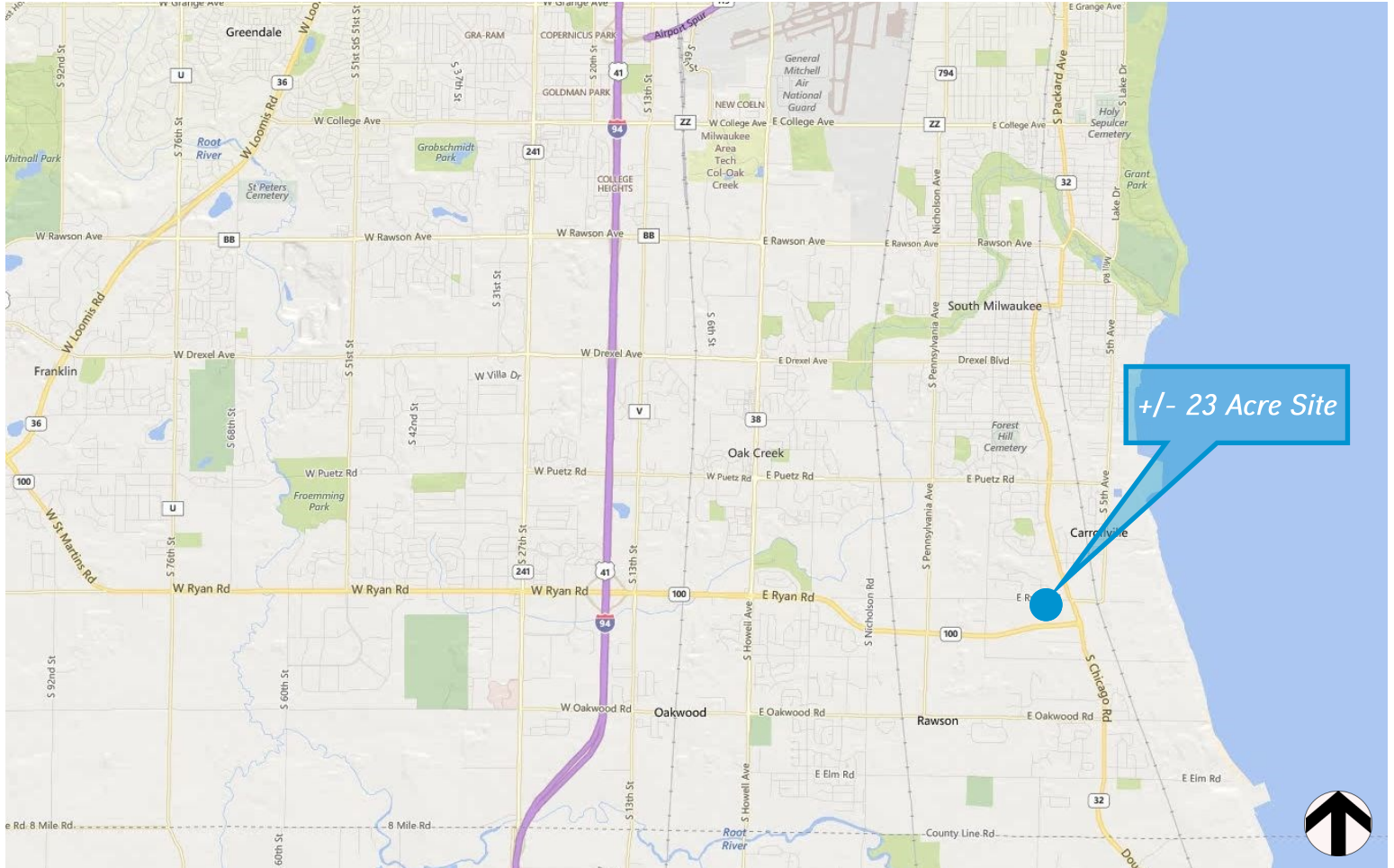

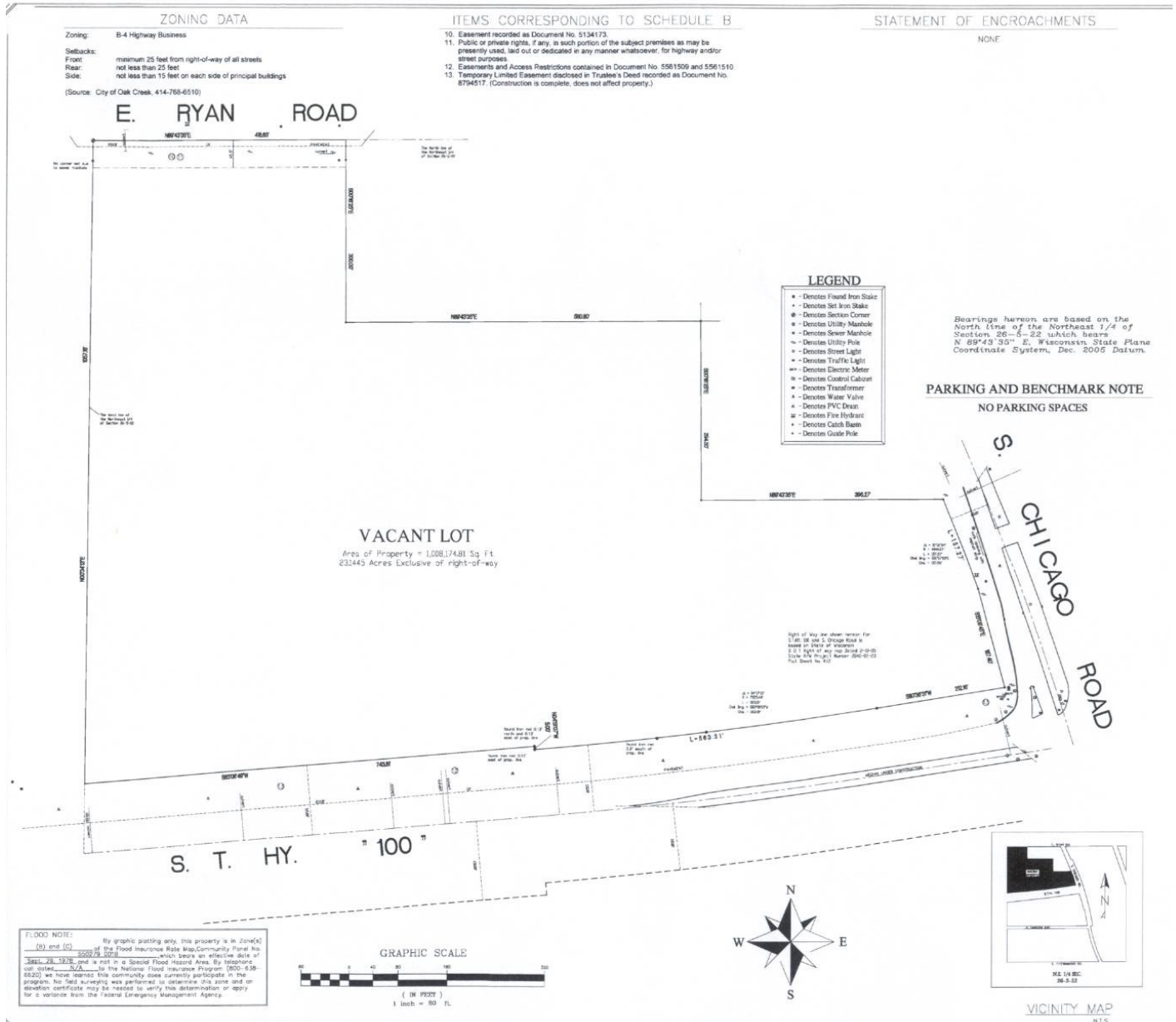

## Site Plan

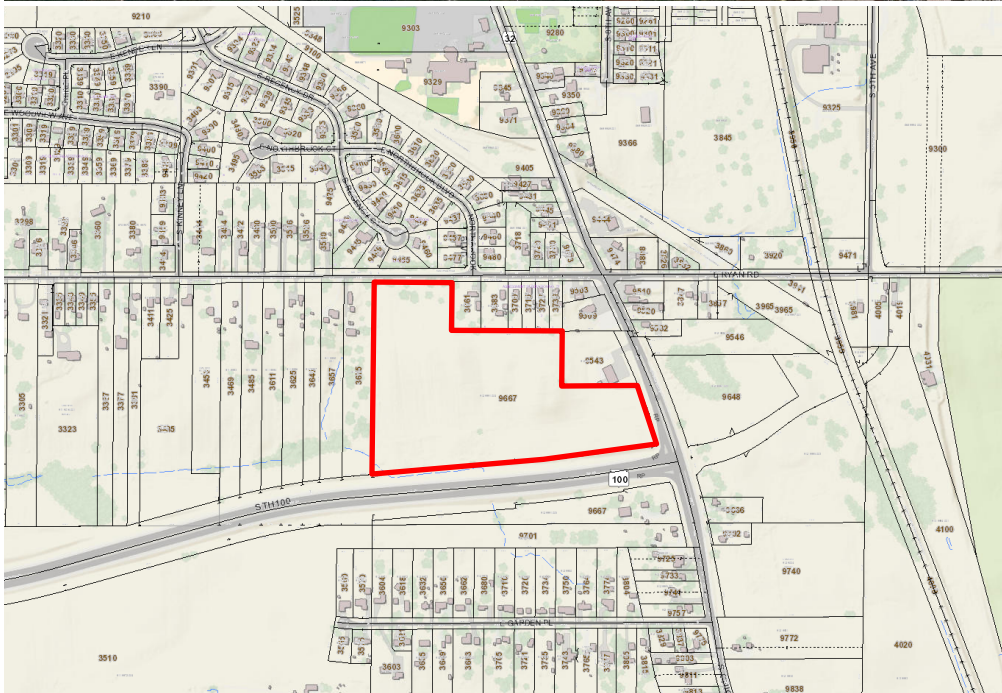
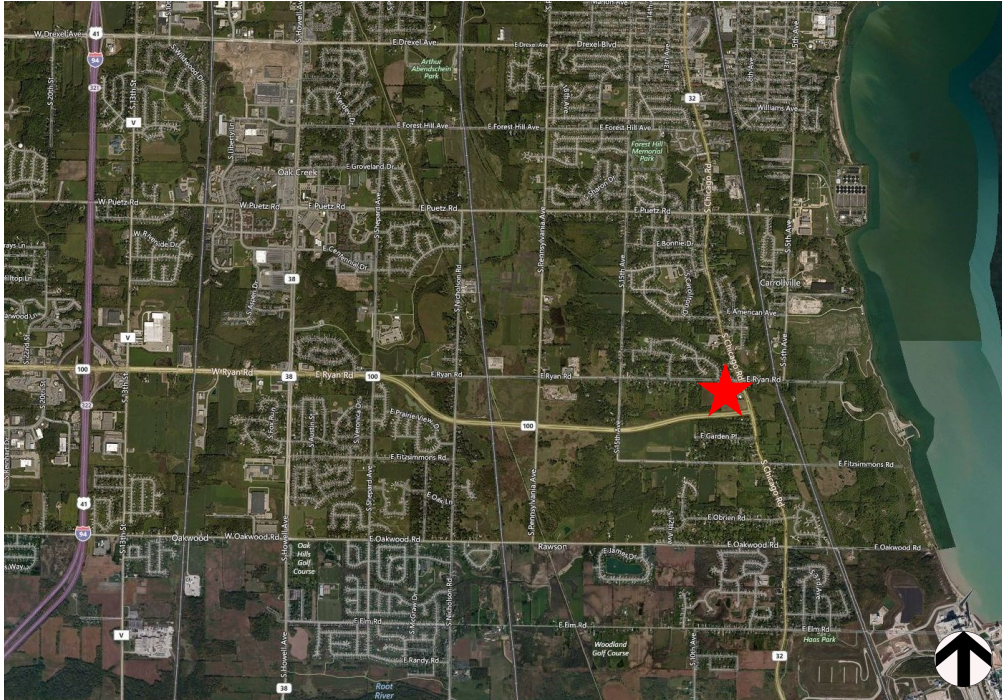
