- Water: City of Wildwood. A 12-inch water line with sufficient capacity is adjacent to the property along State Road 44.

- Wastewater: City of Wildwood. A 10-inch force main with sufficient capacity is approximately 1,900 feet from the property. Estimated timeline for service is six months.
 2.28 MGD in excess capacity
- Natural gas: Eight-inch natural gas line operating at 350 psi can be extended within six months
- Telecom/Fiber: Adjacent to site along County Road 219




