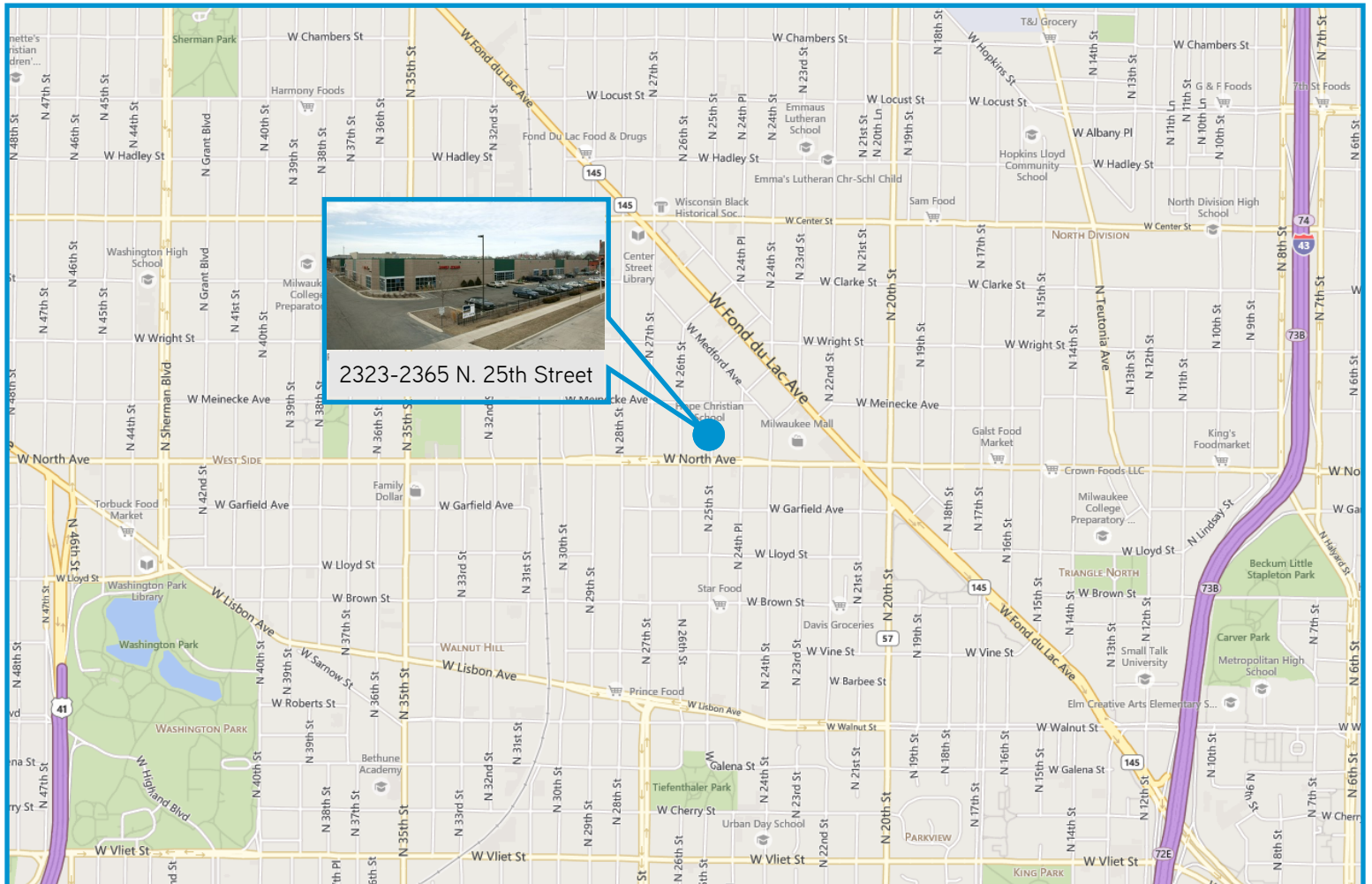

## Retail Location Map



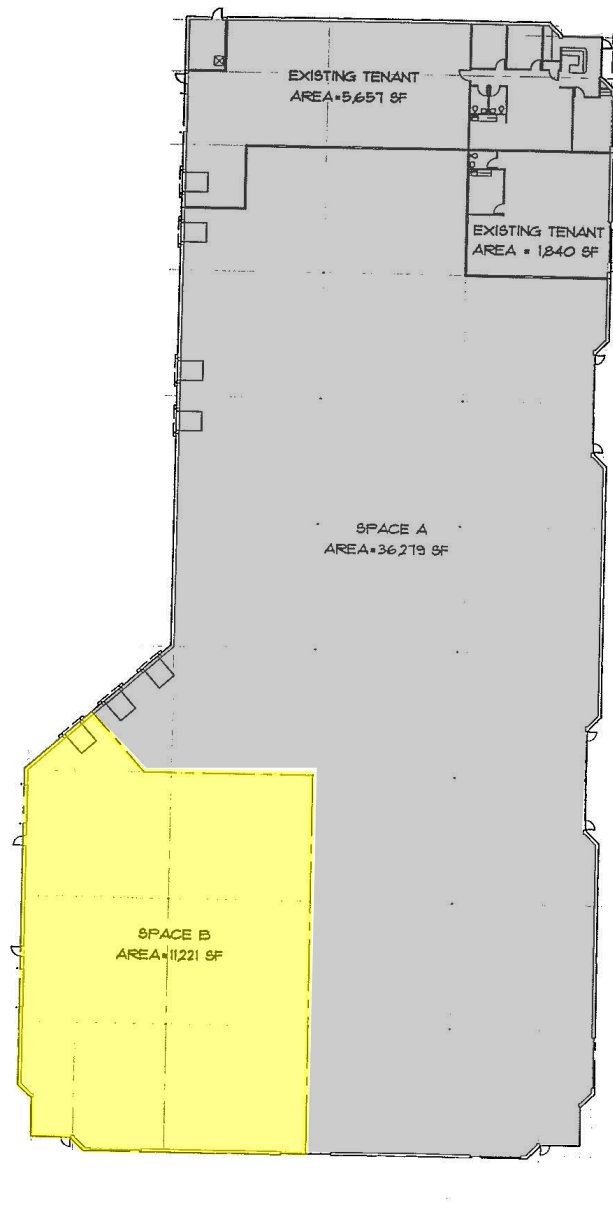

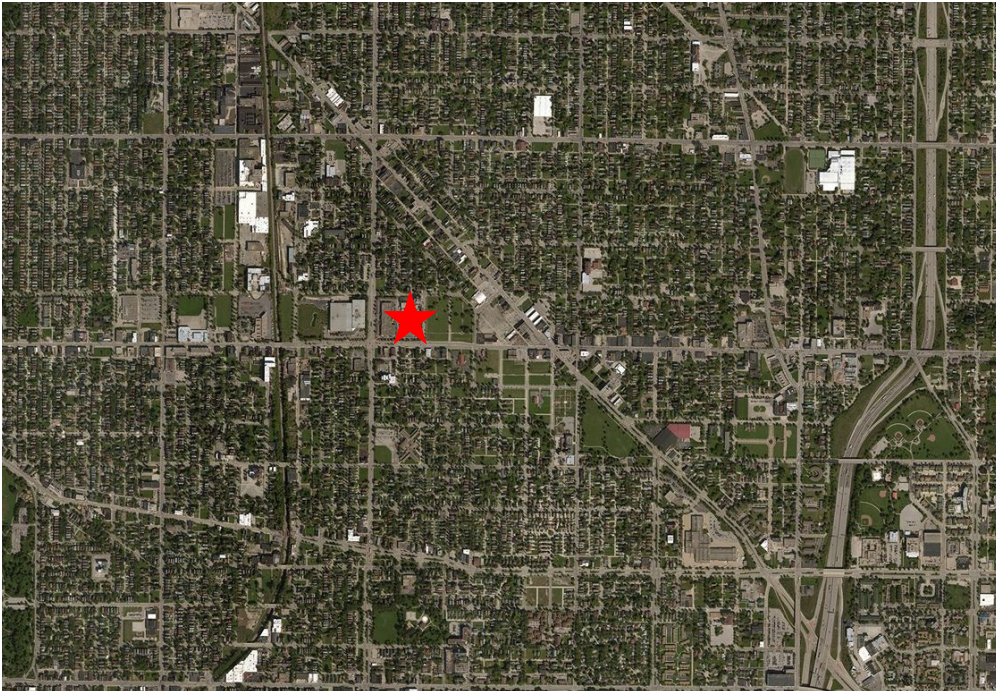
## Floor Plan
