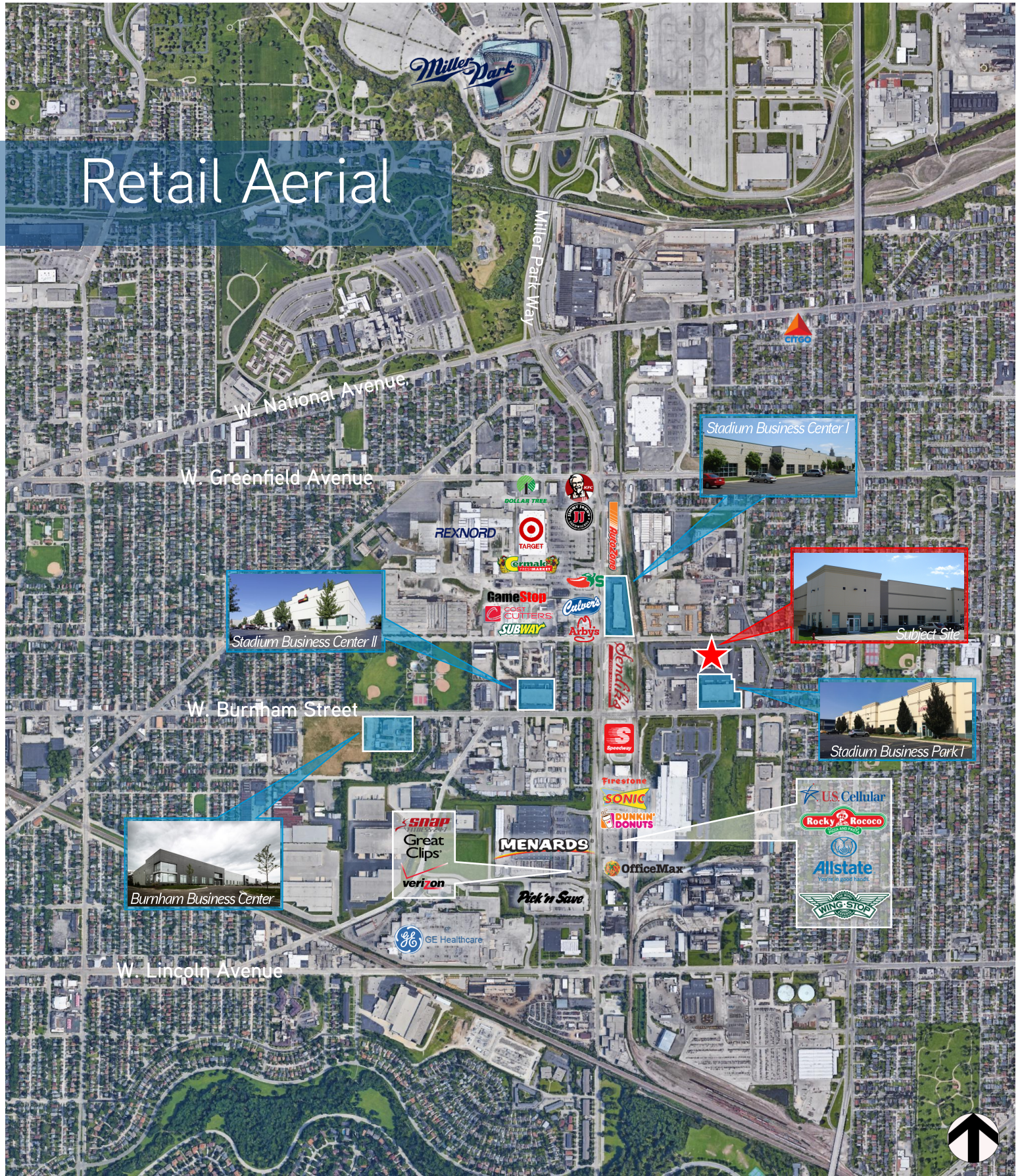

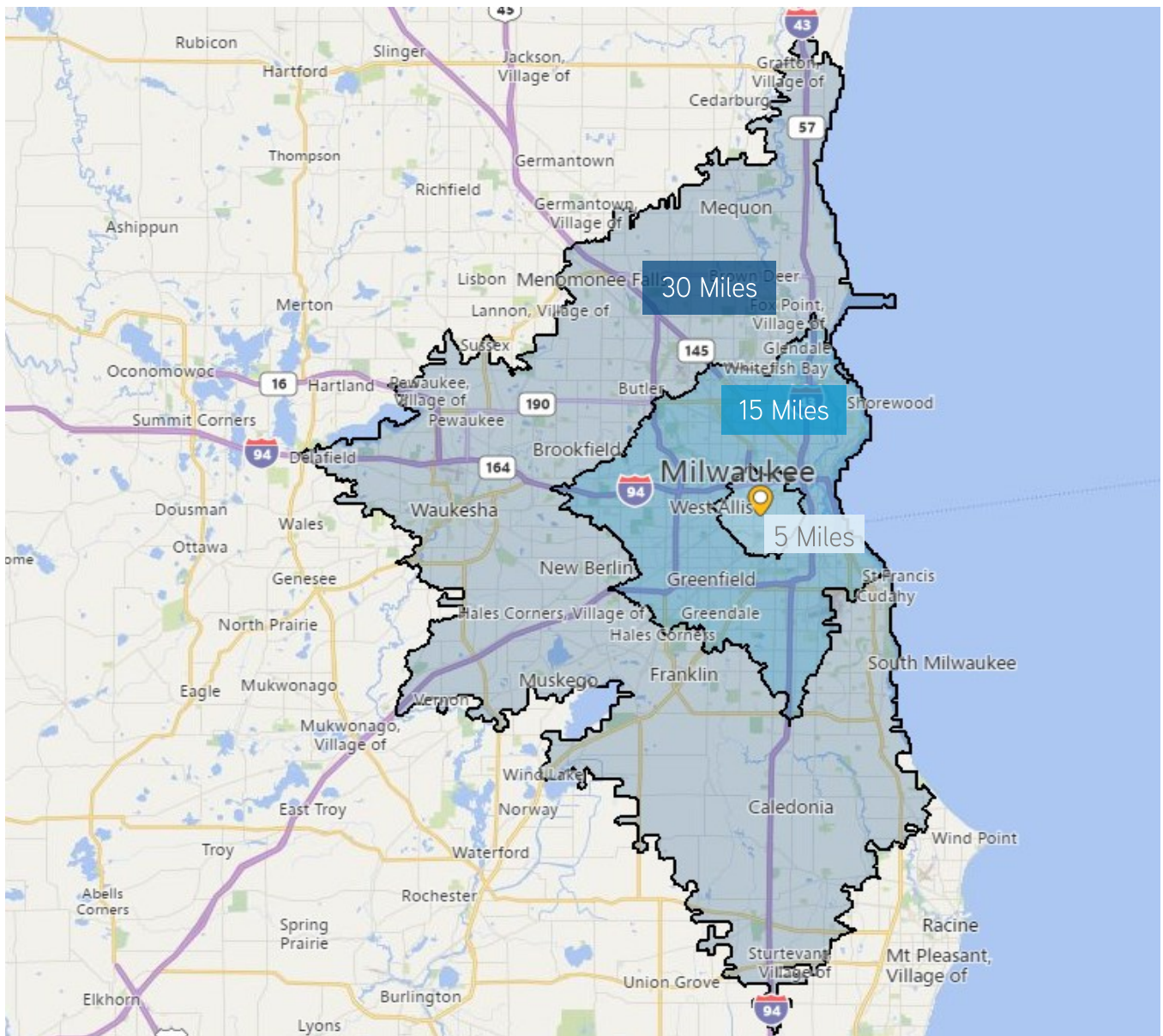

## Drive Time Map



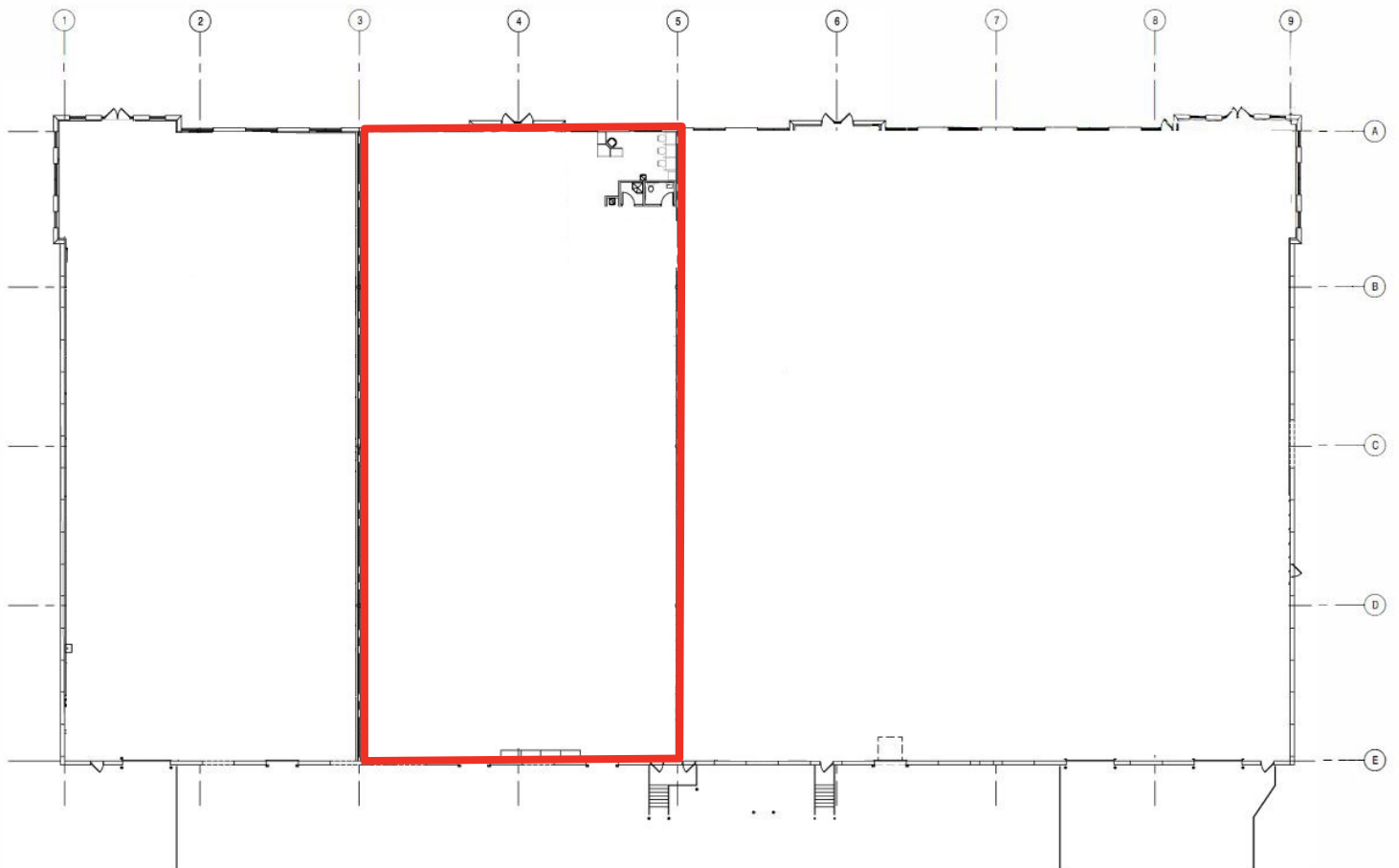
