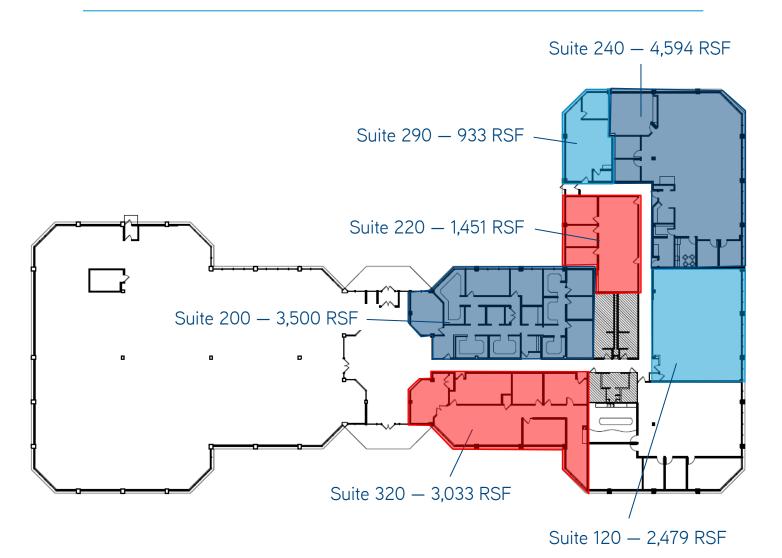
Location Map
