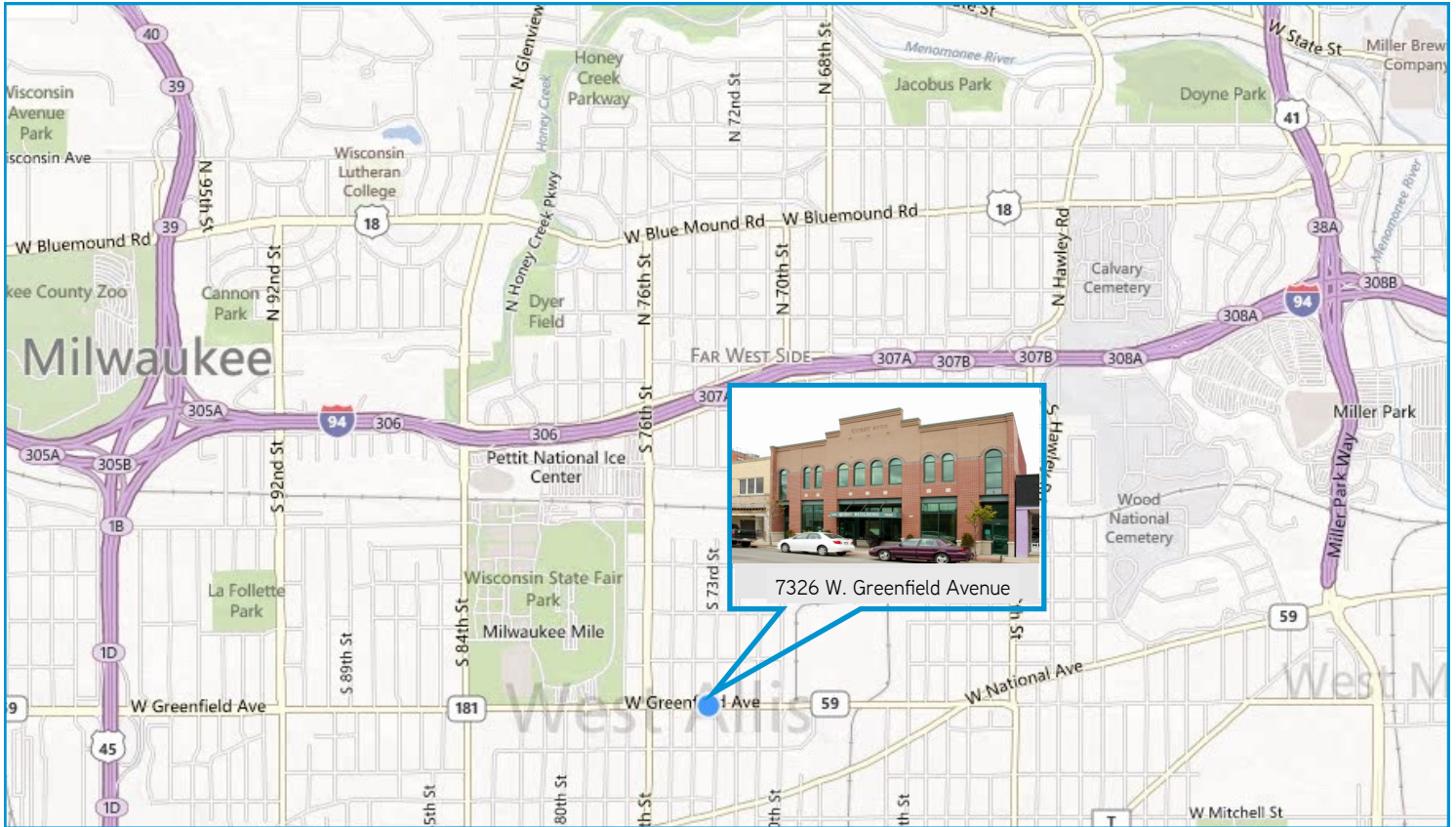

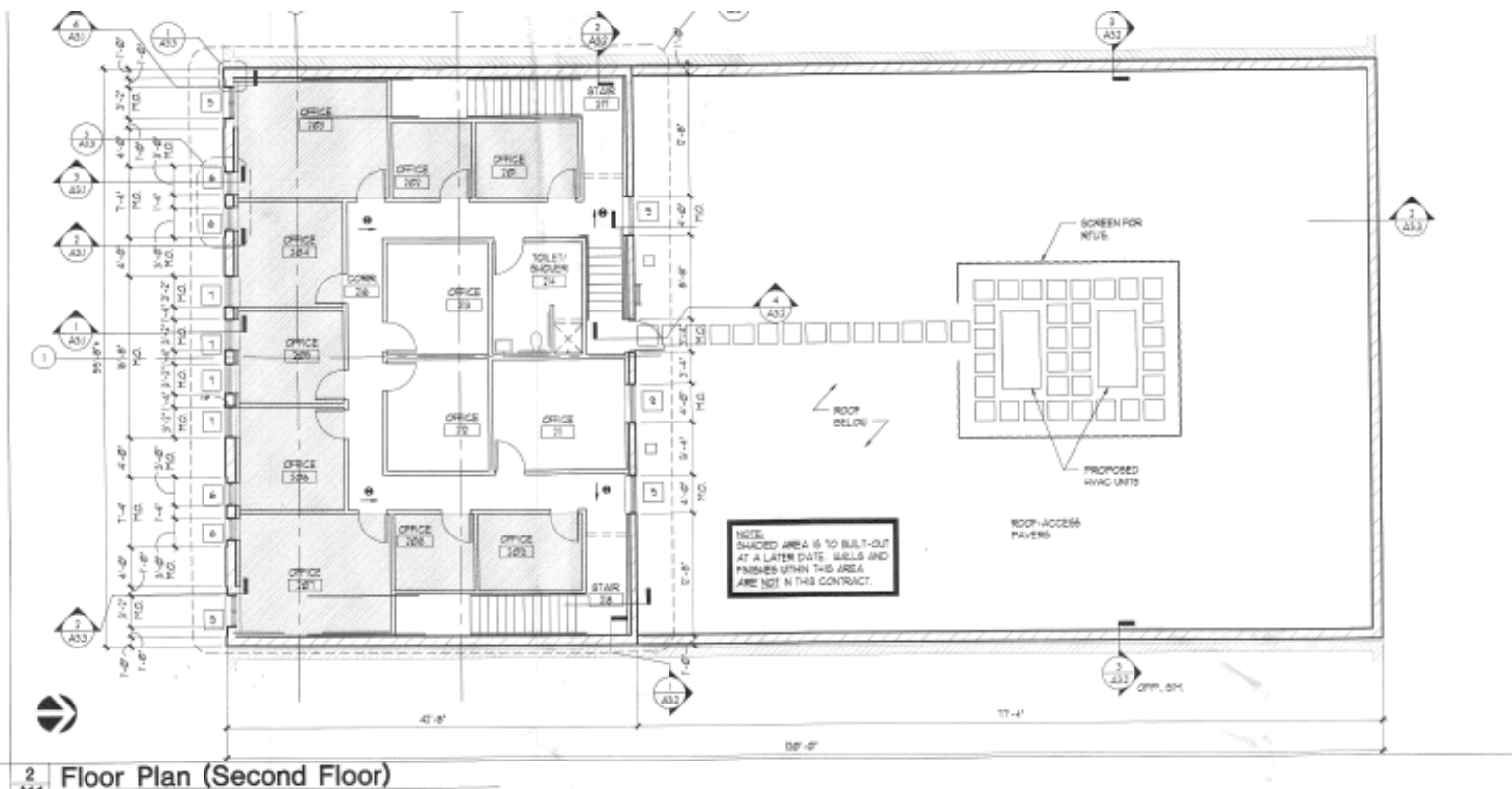

## Second Floor Plan-

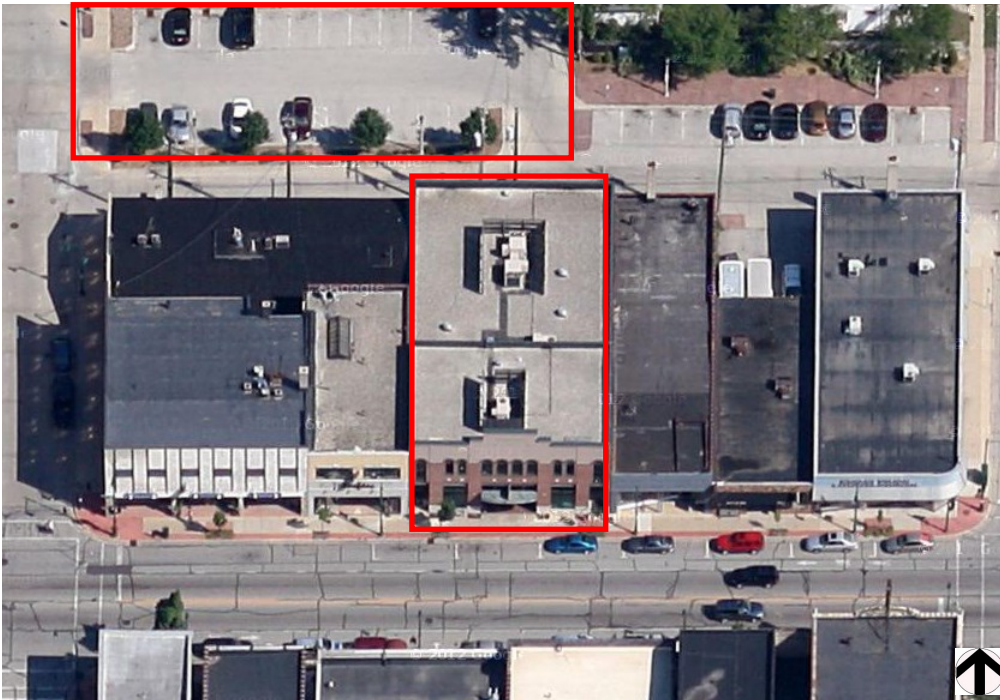
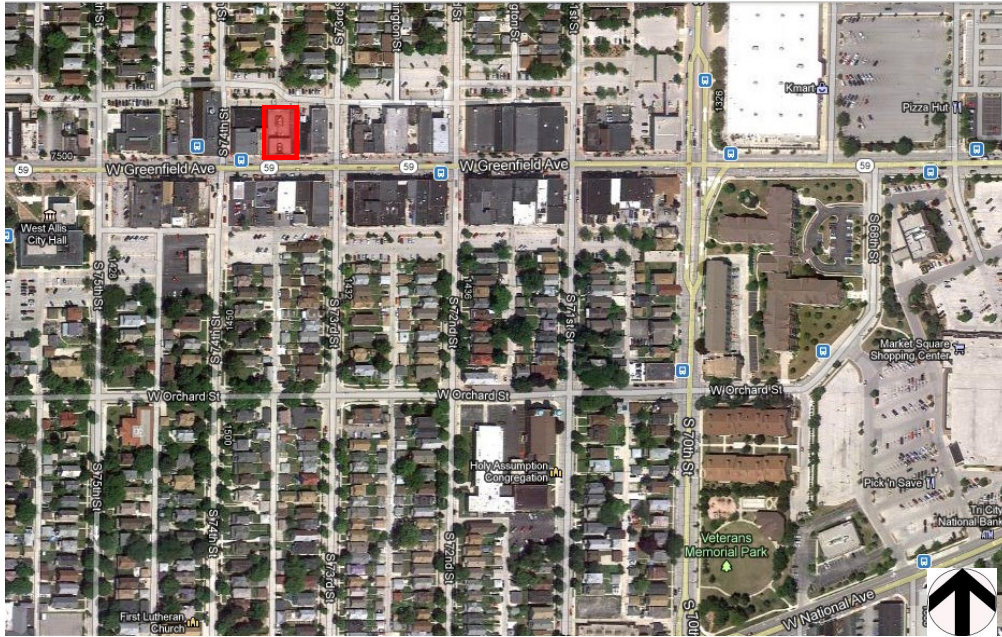
