#### **Location Overview**

The subject property is located in the rapidly developing south submarket of Houston just one block west of Highway 288 in Pearland. It is adjacent to Pearland Town Center, a 1.2 million square foot outdoor shopping mall with tenants such as Dillard's, Macy's, Barnes & Noble, Forever 21, and the newly opened Dick's Sporting Goods. It also has immediate access to multiple dining establishments and medical campuses, including Memorial Hermann and Kelsey Seybold. The property is also adjacent to the newly constructed Costco, Jimmy Changas restaurant, iShine Car Wash & Detail, a retail center and a medical center that is now under construction. The Highway 288 corridor of Pearland features favorable demographics with the addition of Sedona Lakes, Pomona, and the Meridiana residential developments, the area has seen a 45% growth rate since 2010.




