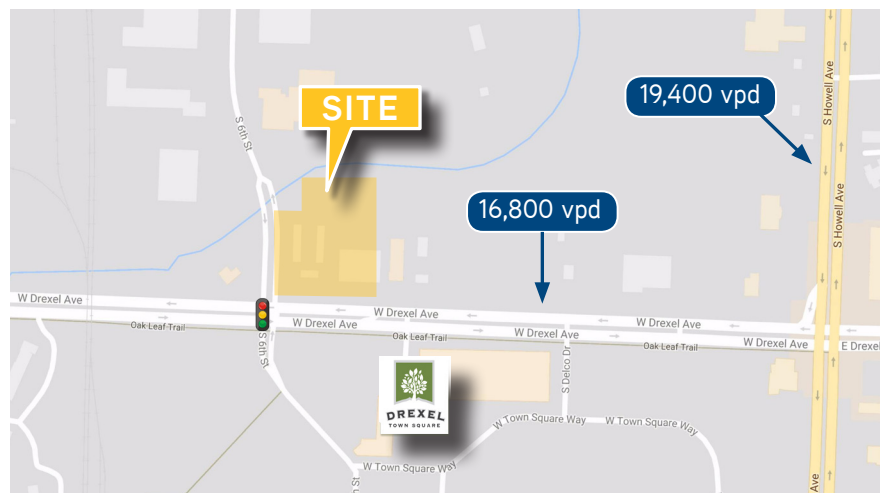

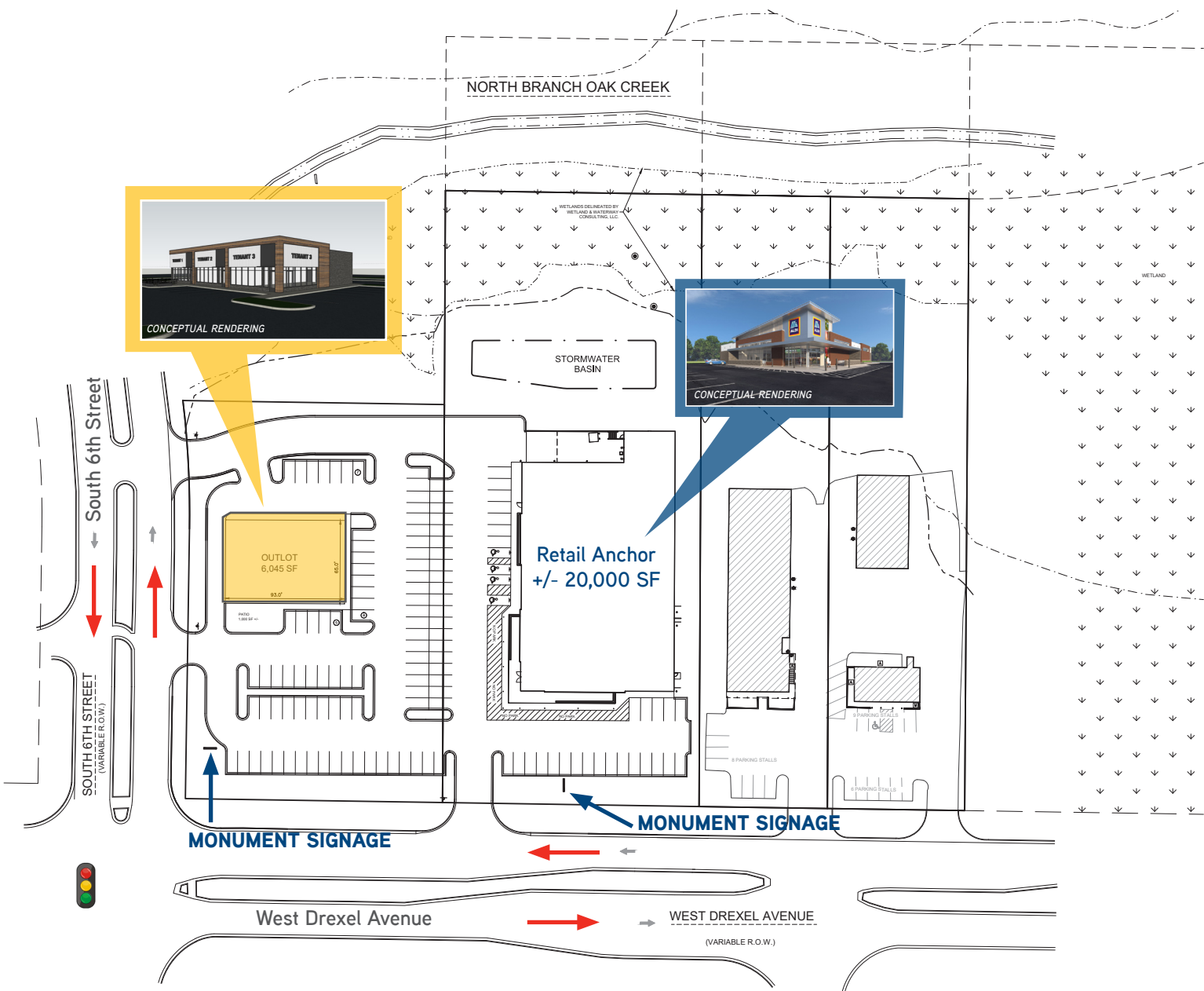

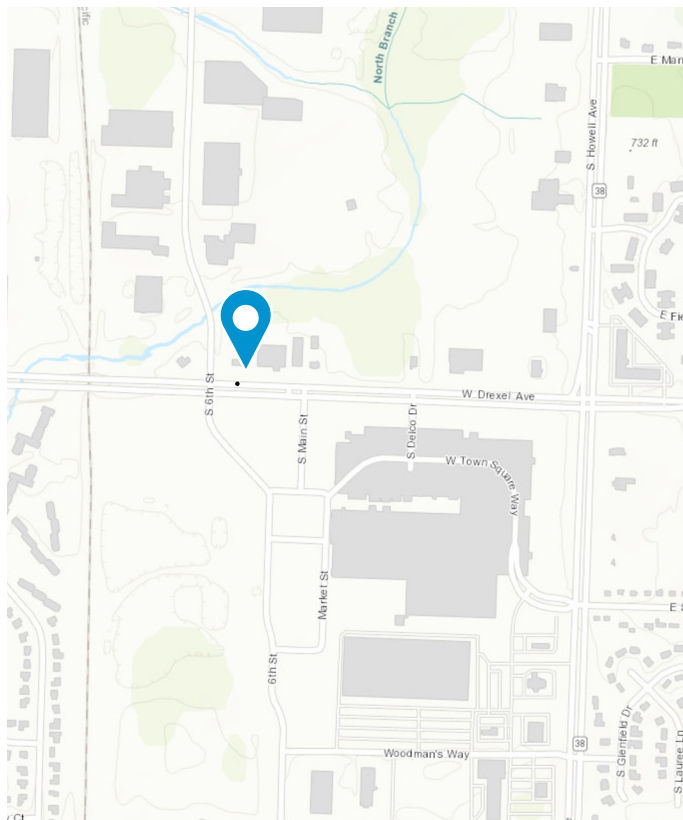
Site Plan - Free-Standing Building

BROKER DISCLOSURE TO CUSTOMERS
