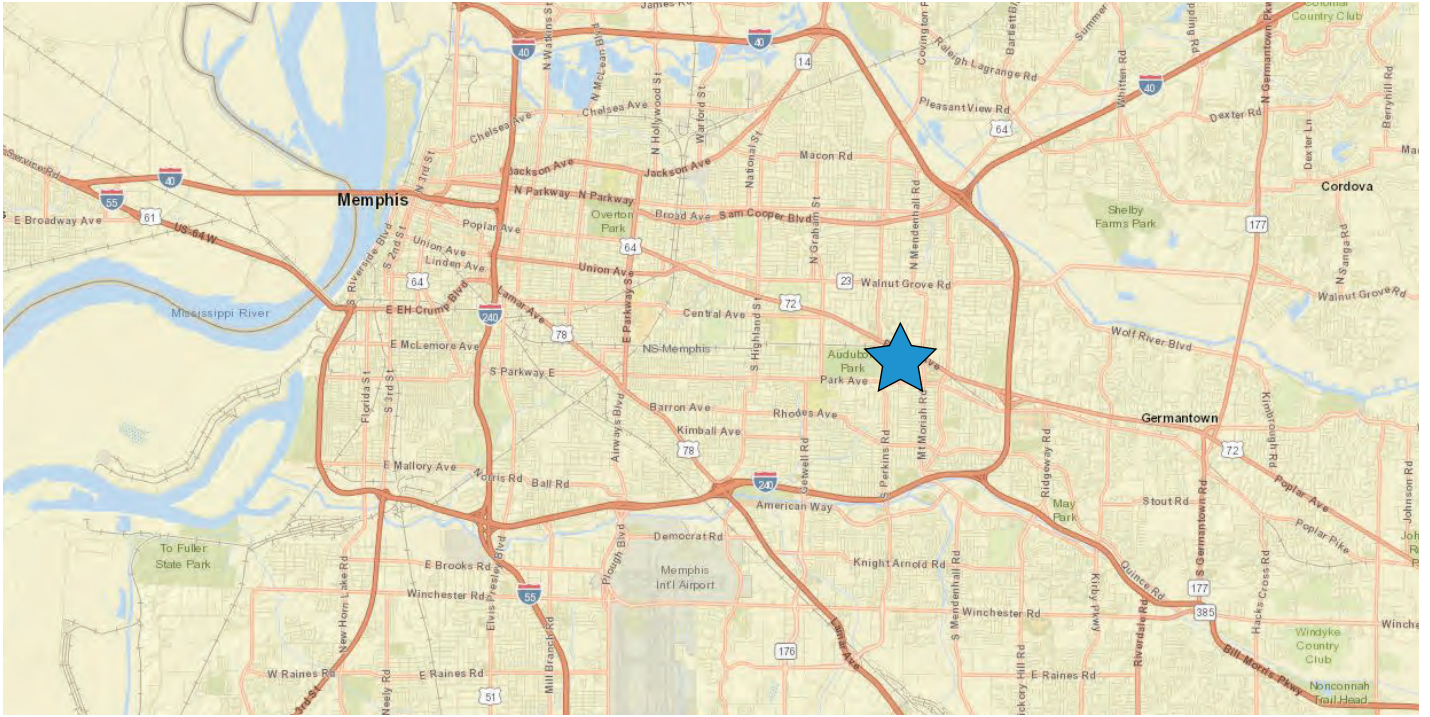
PROPERTY DESCRIPTION
