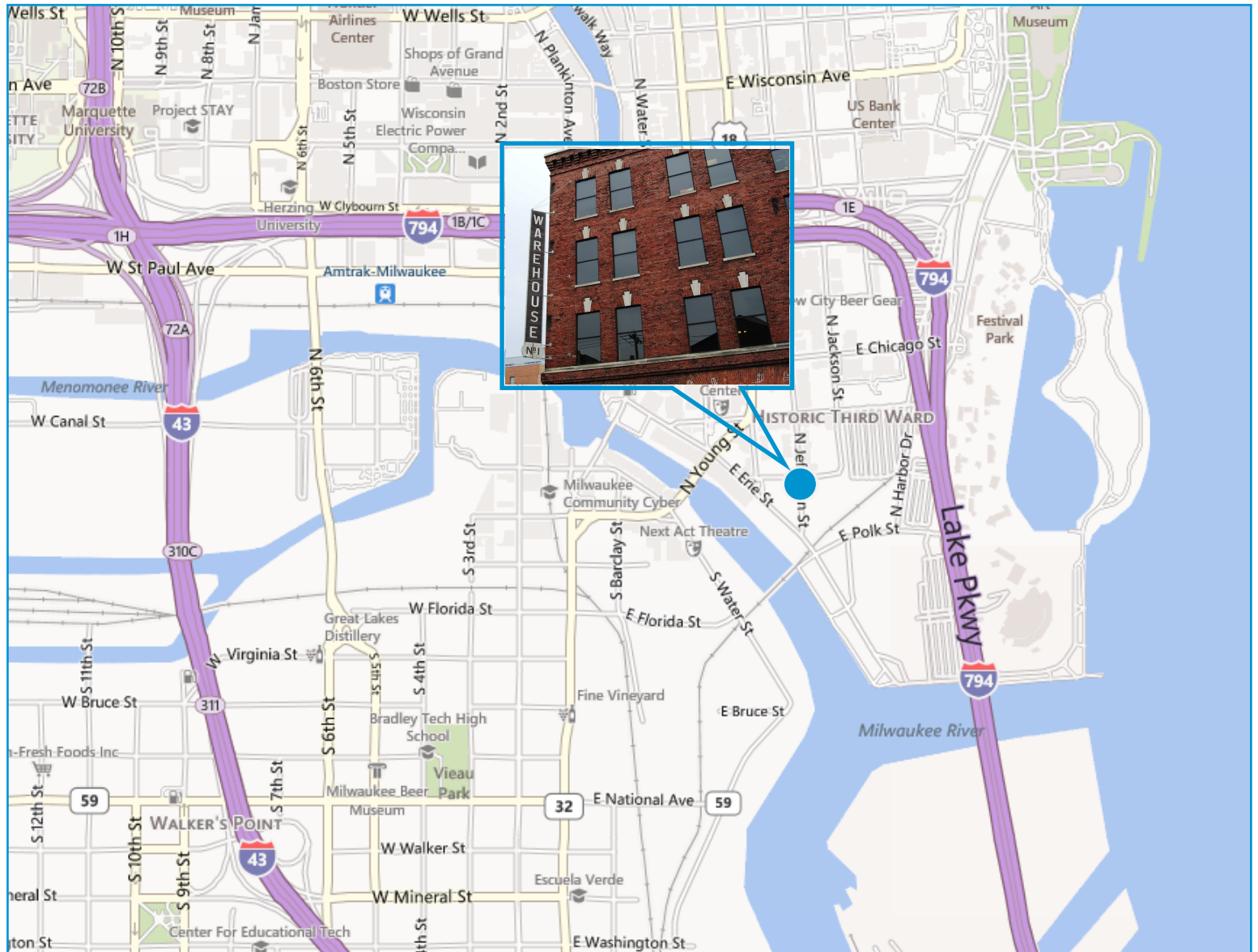

## Location Map

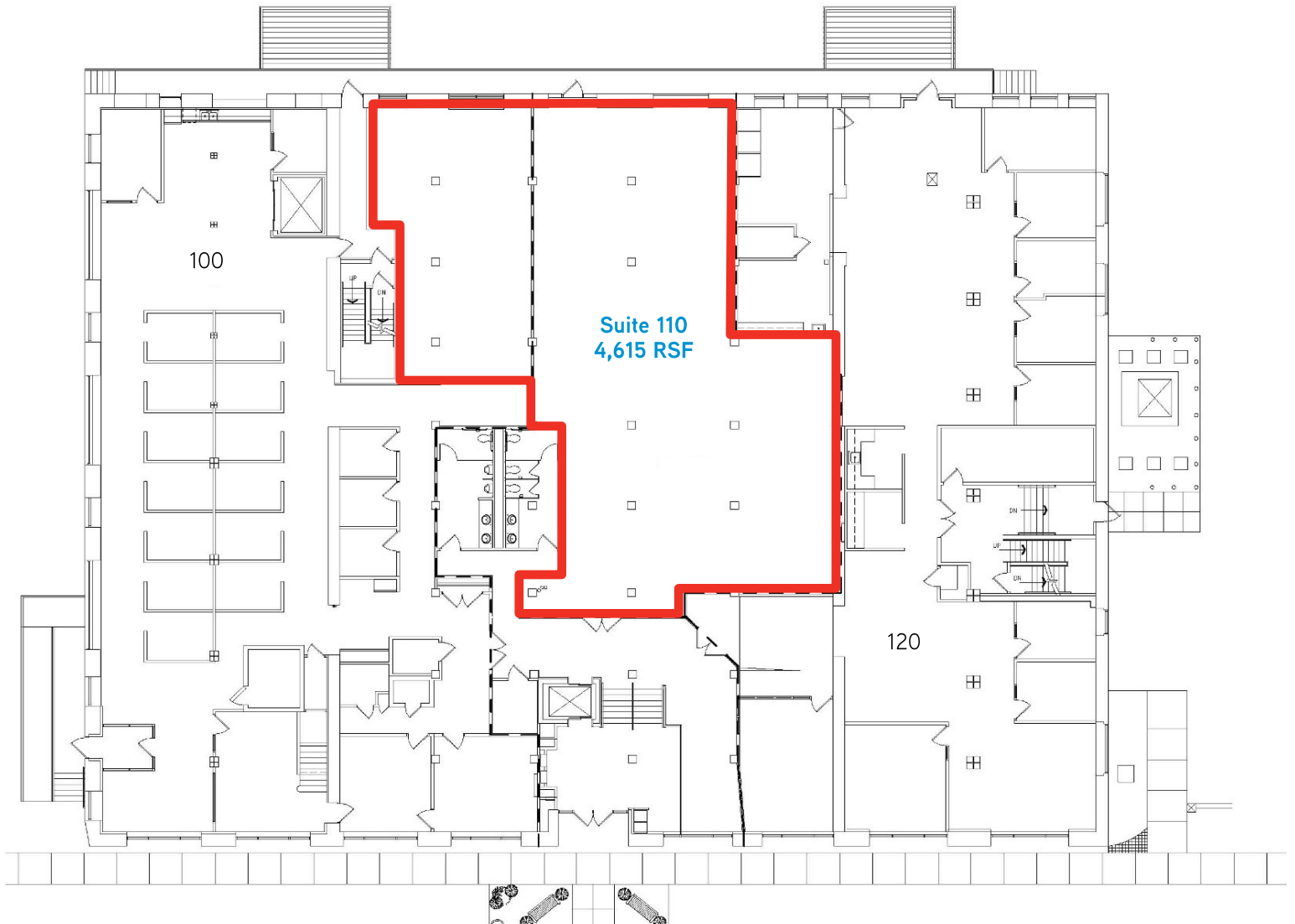

## Floor Plan - First Floor



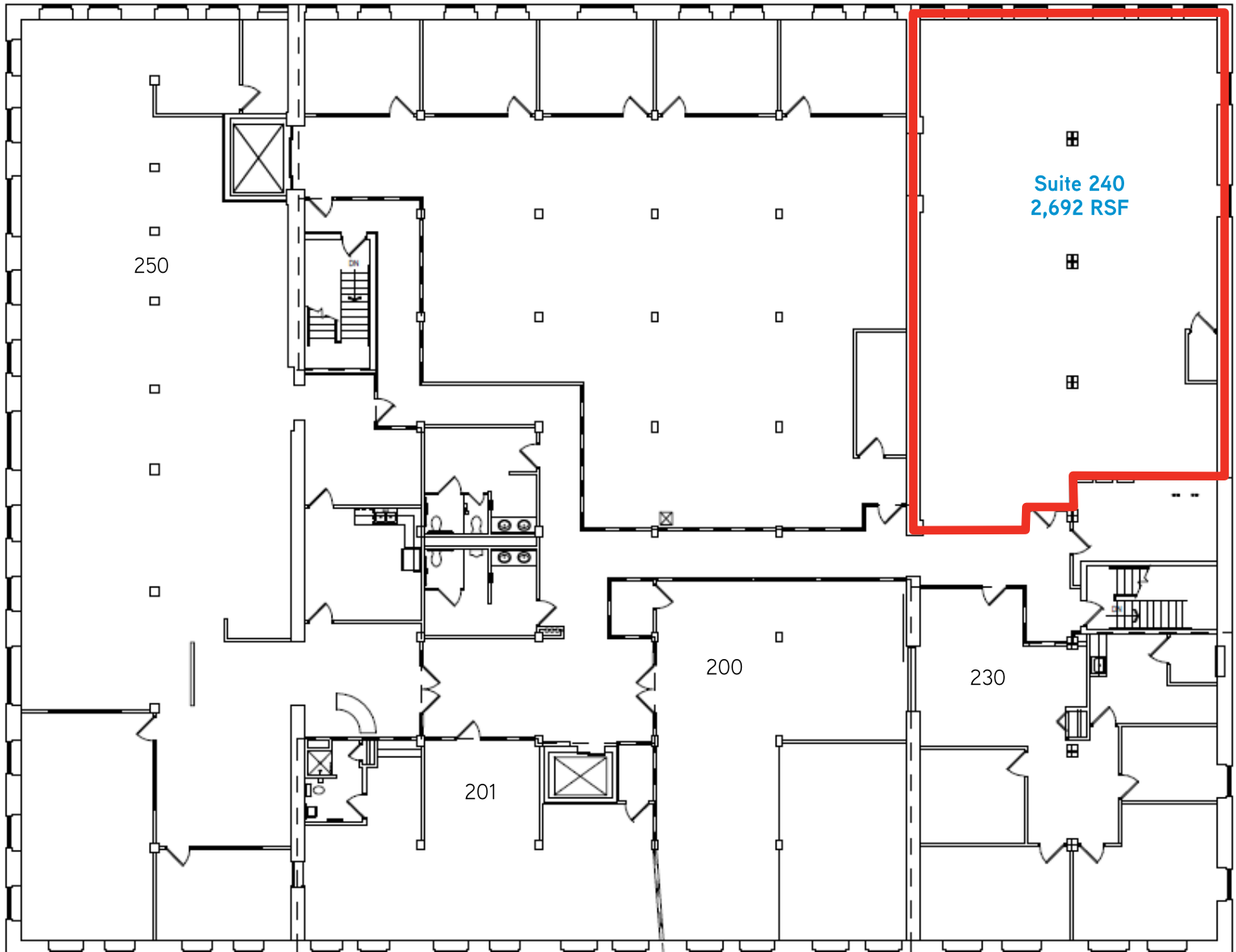
