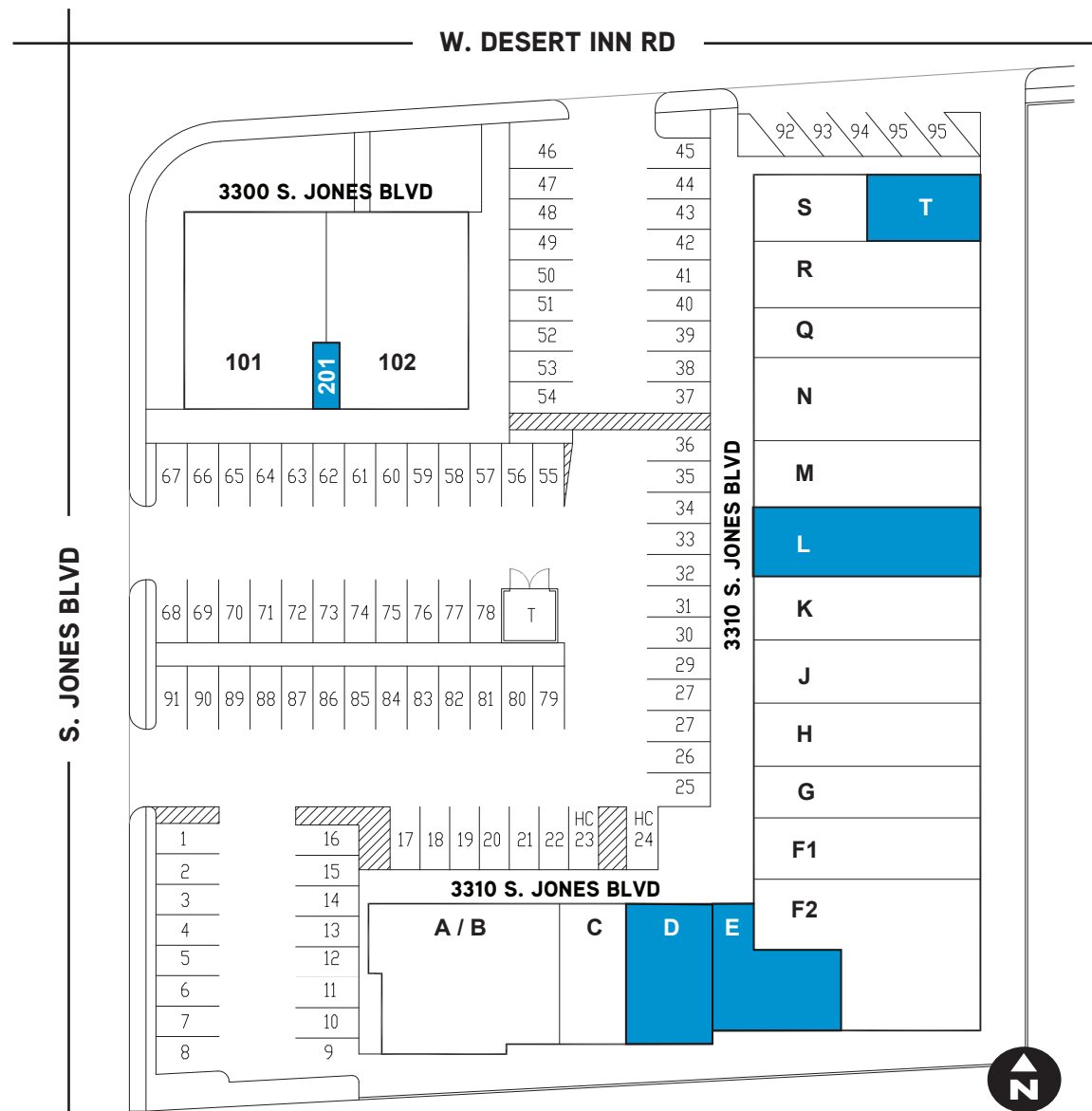

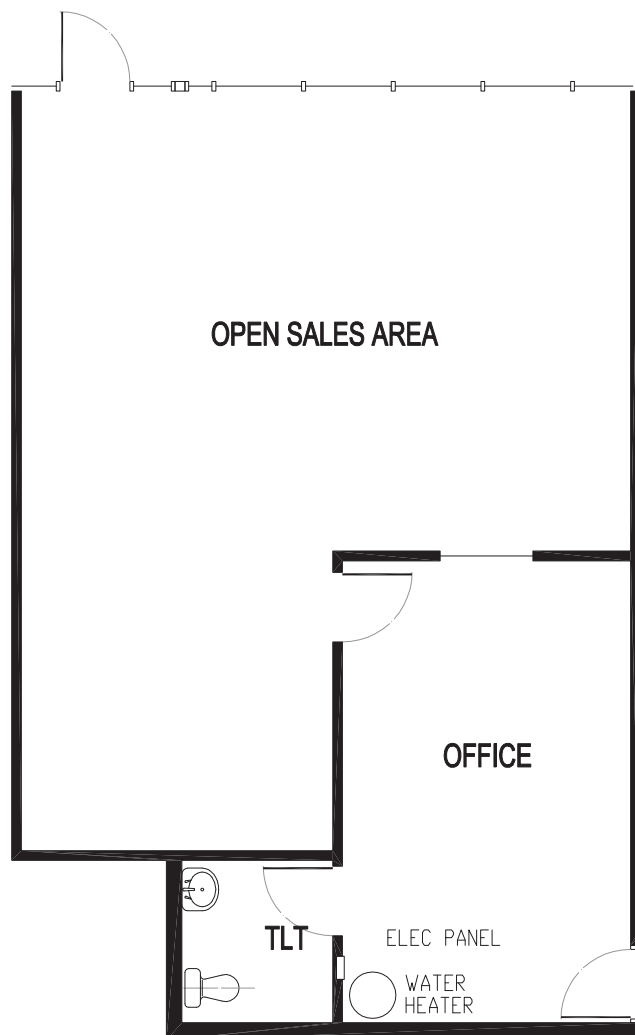
SITE PLAN

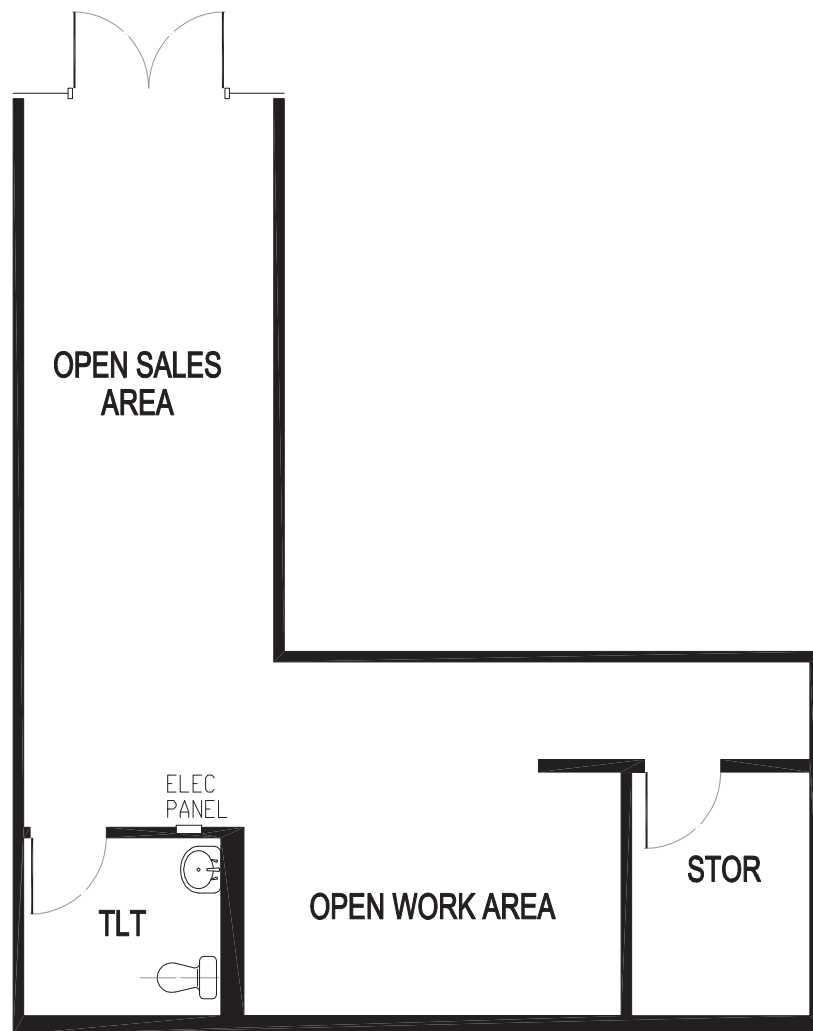

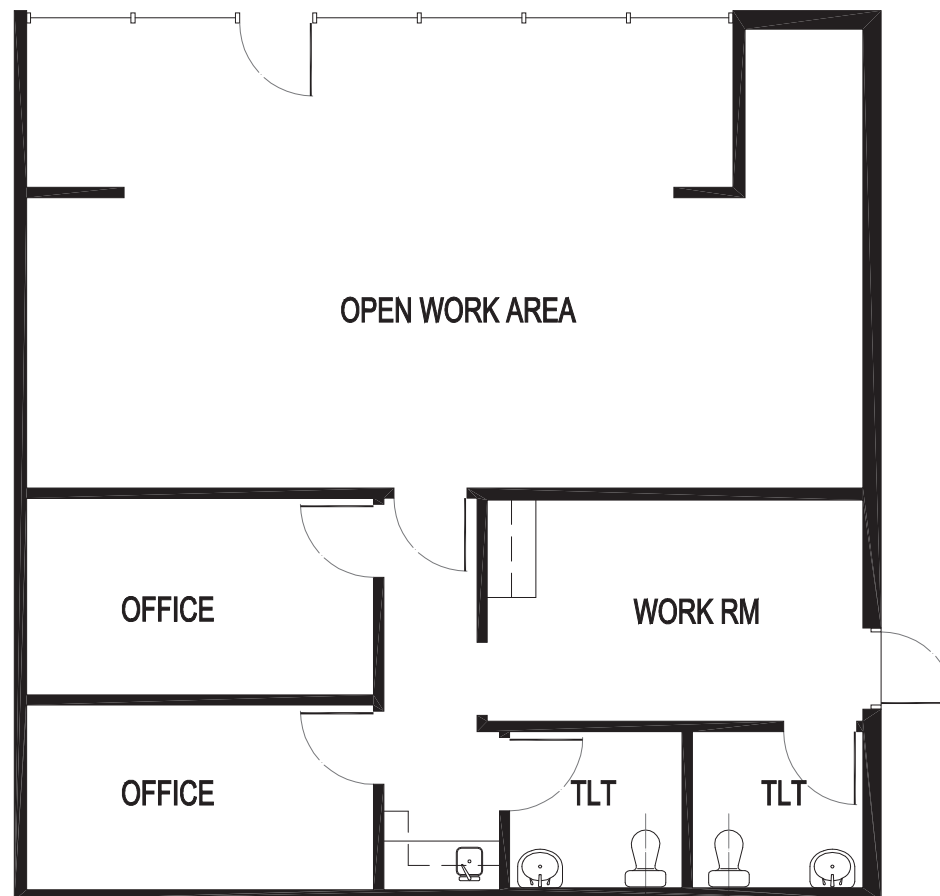

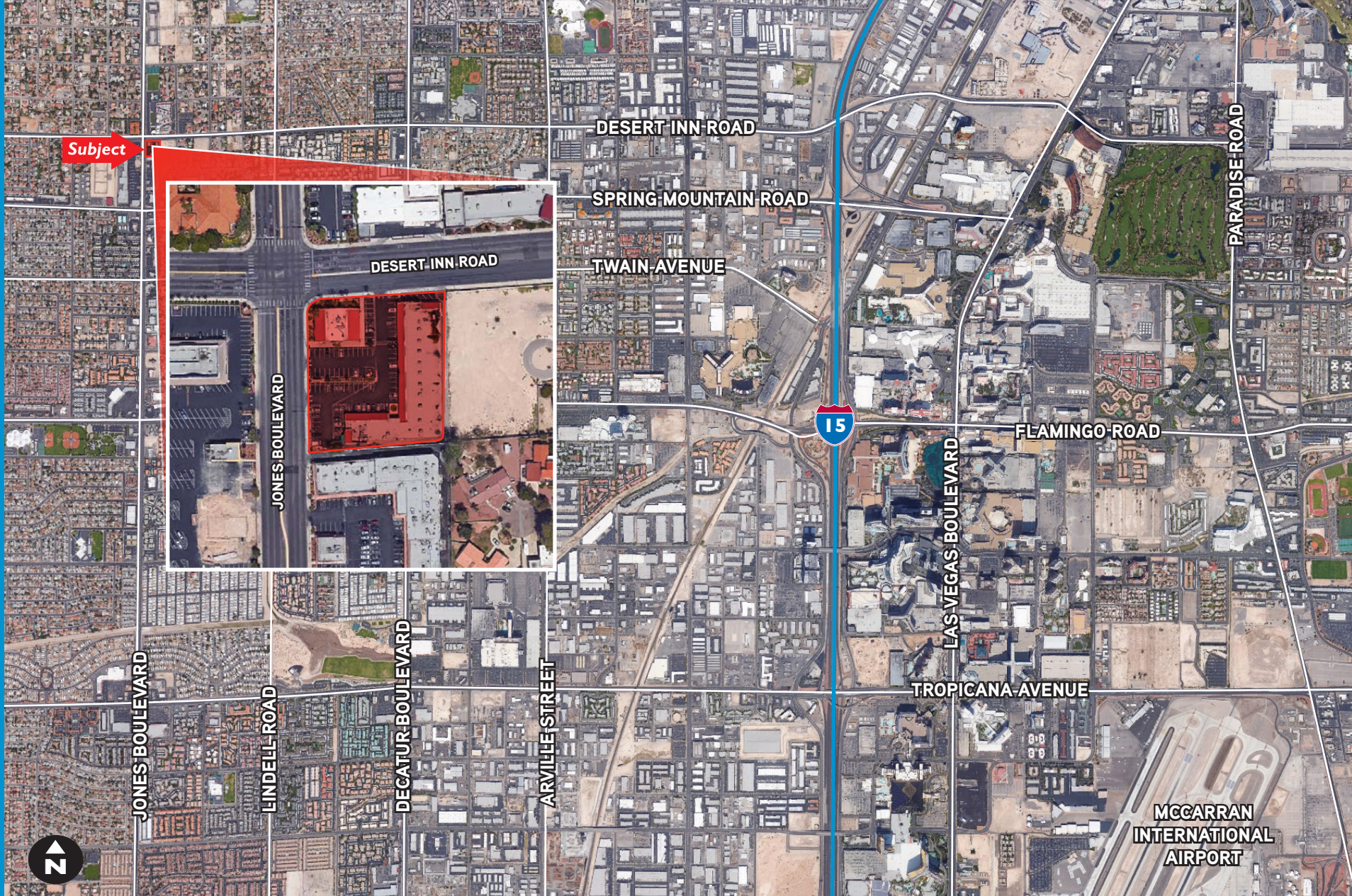
