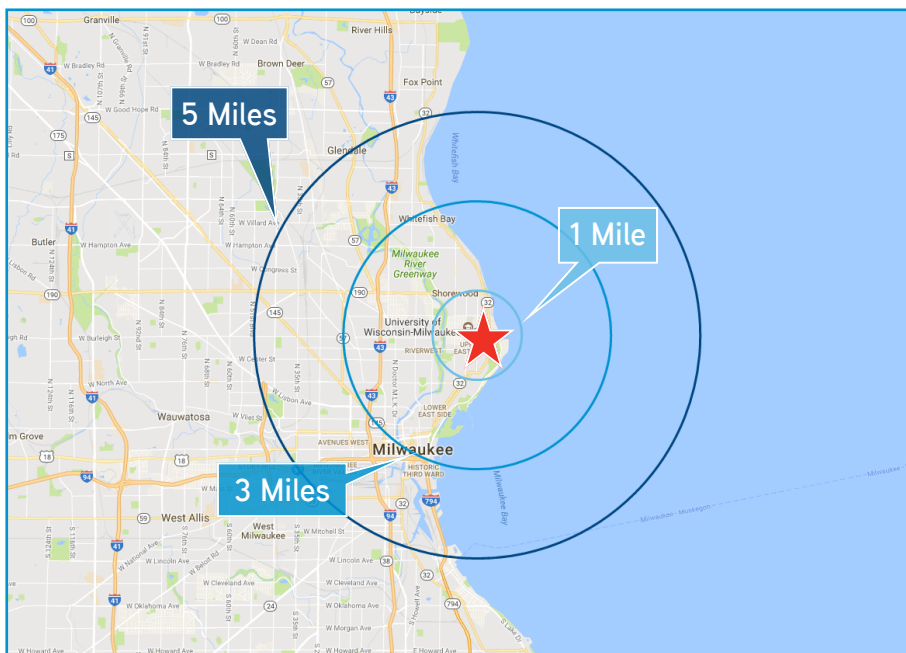

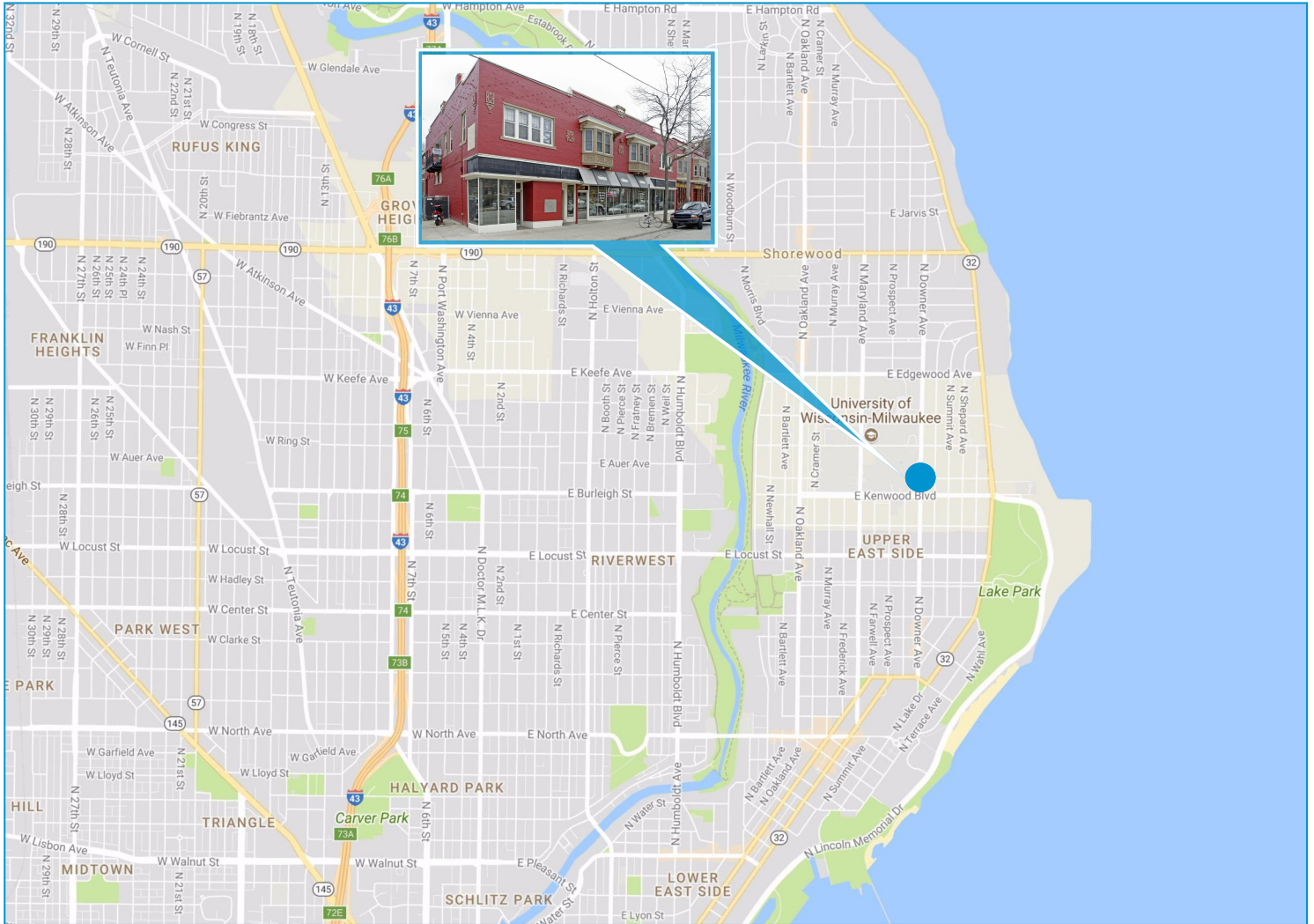

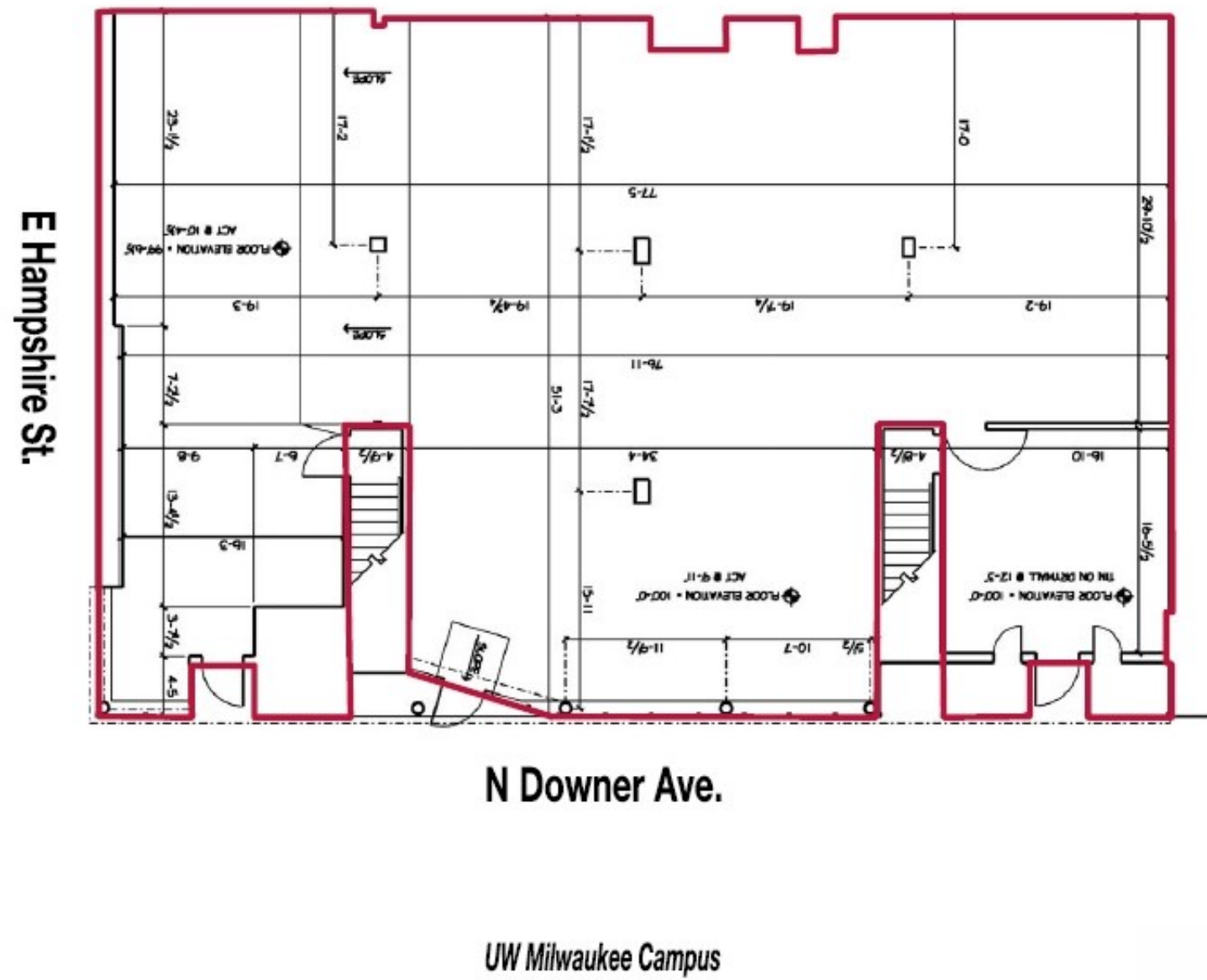
## Retail Map

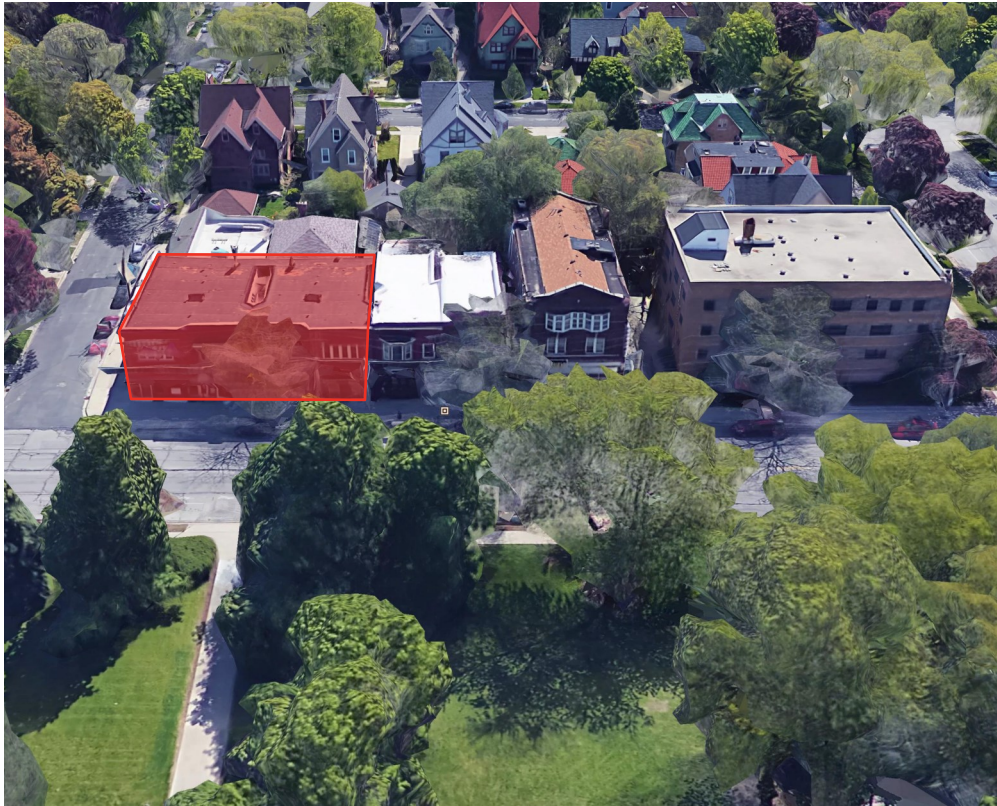

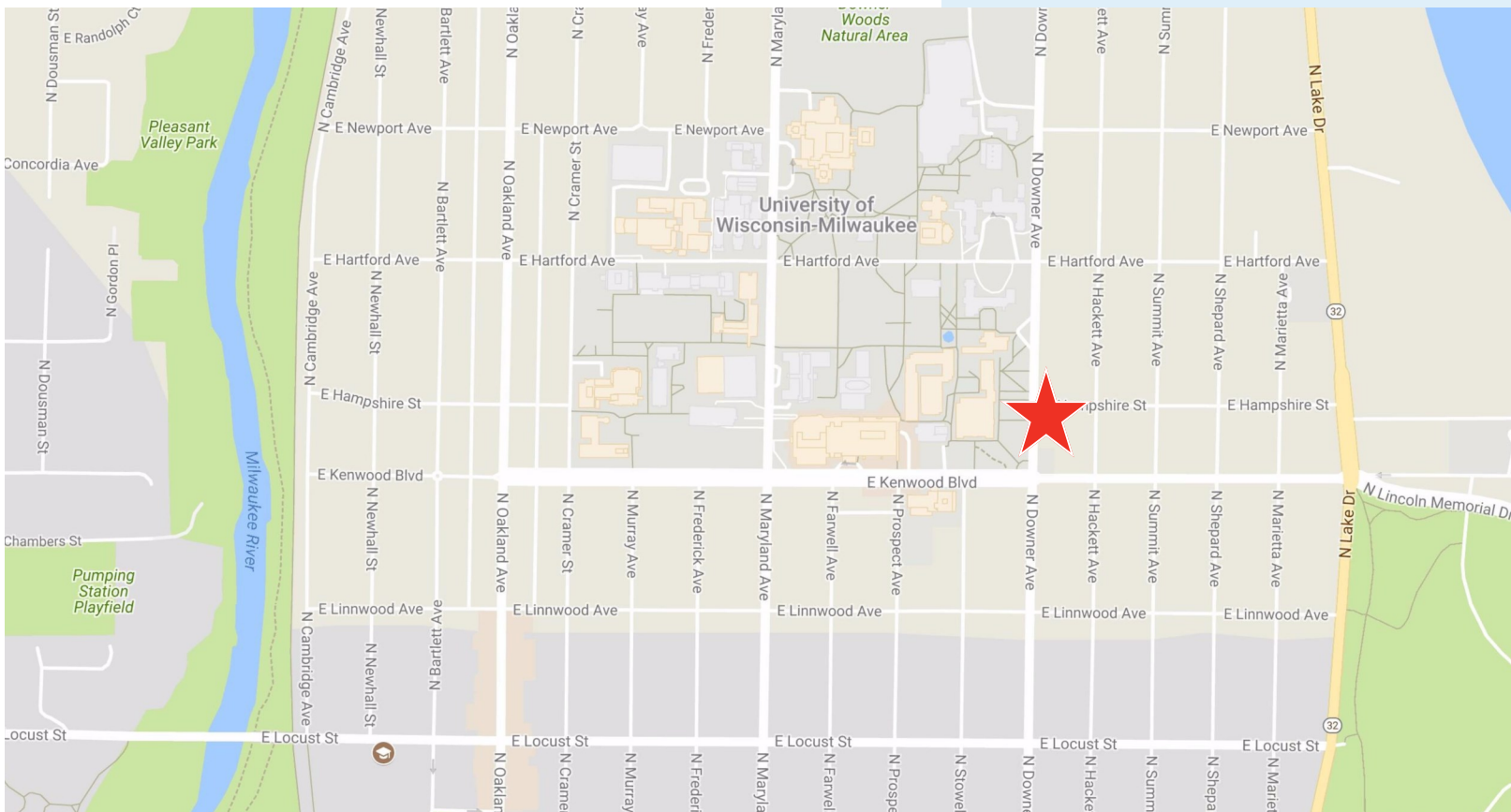
