






DOWNTOWN ENTERTAINMENT AND HOSPITALITY OVERVIEW



BROKER DISCLOSURE TO NON-RESIDENTIAL CUSTOMERS

1 Prior to negotiating on your behalf the Broker must provide you the following disclosure statement:
