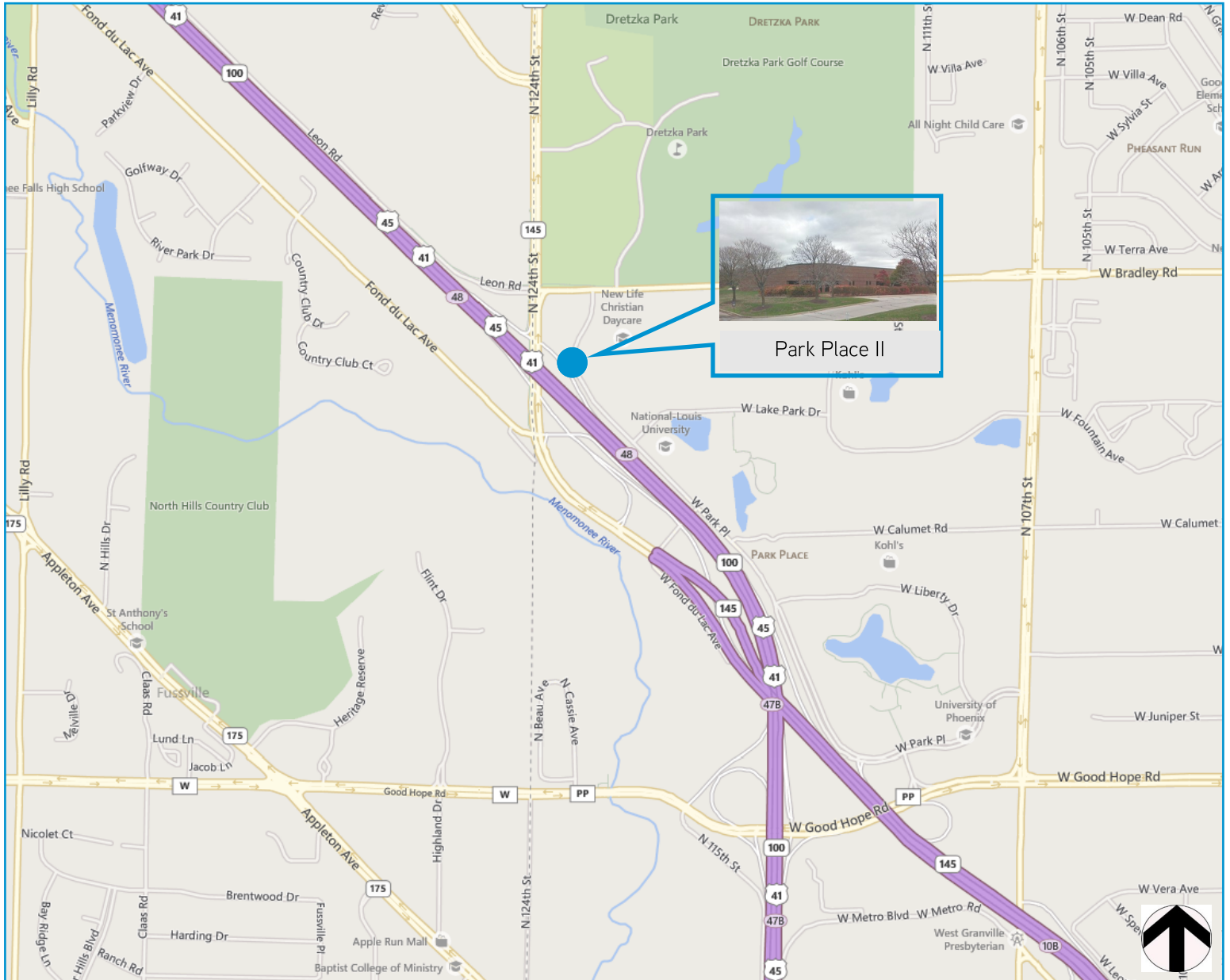

Location Map

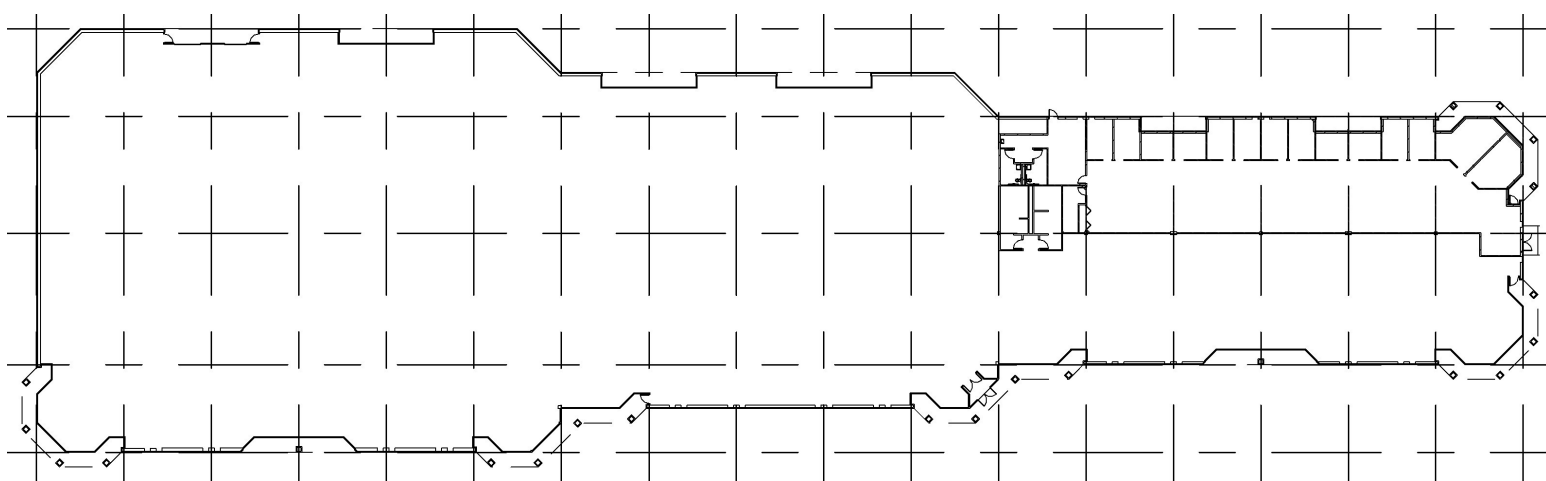
