

# **Executive Summary**

Rare opportunity to acquire a prime piece of land for multifamily development along Lake Michigan. Property is located at the end of Depot Road with ±430 lineal feet of Lake Michigan frontage and falls within the midst of the major Lake Vista redevelopment project. City of Oak Creek Comprehensive Plan calls for this land to be utilized for multifamily development and has the potential for city approval of 20–32 units per acre. City is planning \$15 million in infrastructure work for redevelopment including extension of 5th Avenue to connect to Highway 100.


