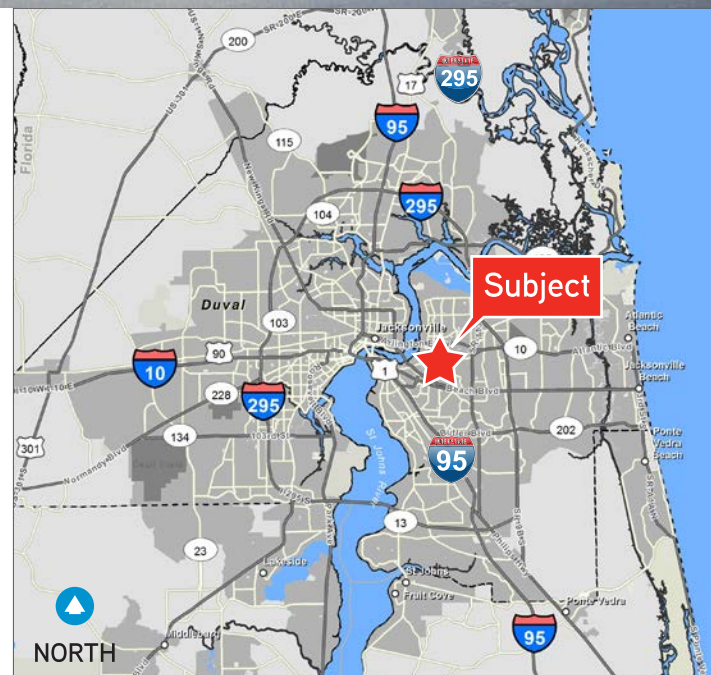

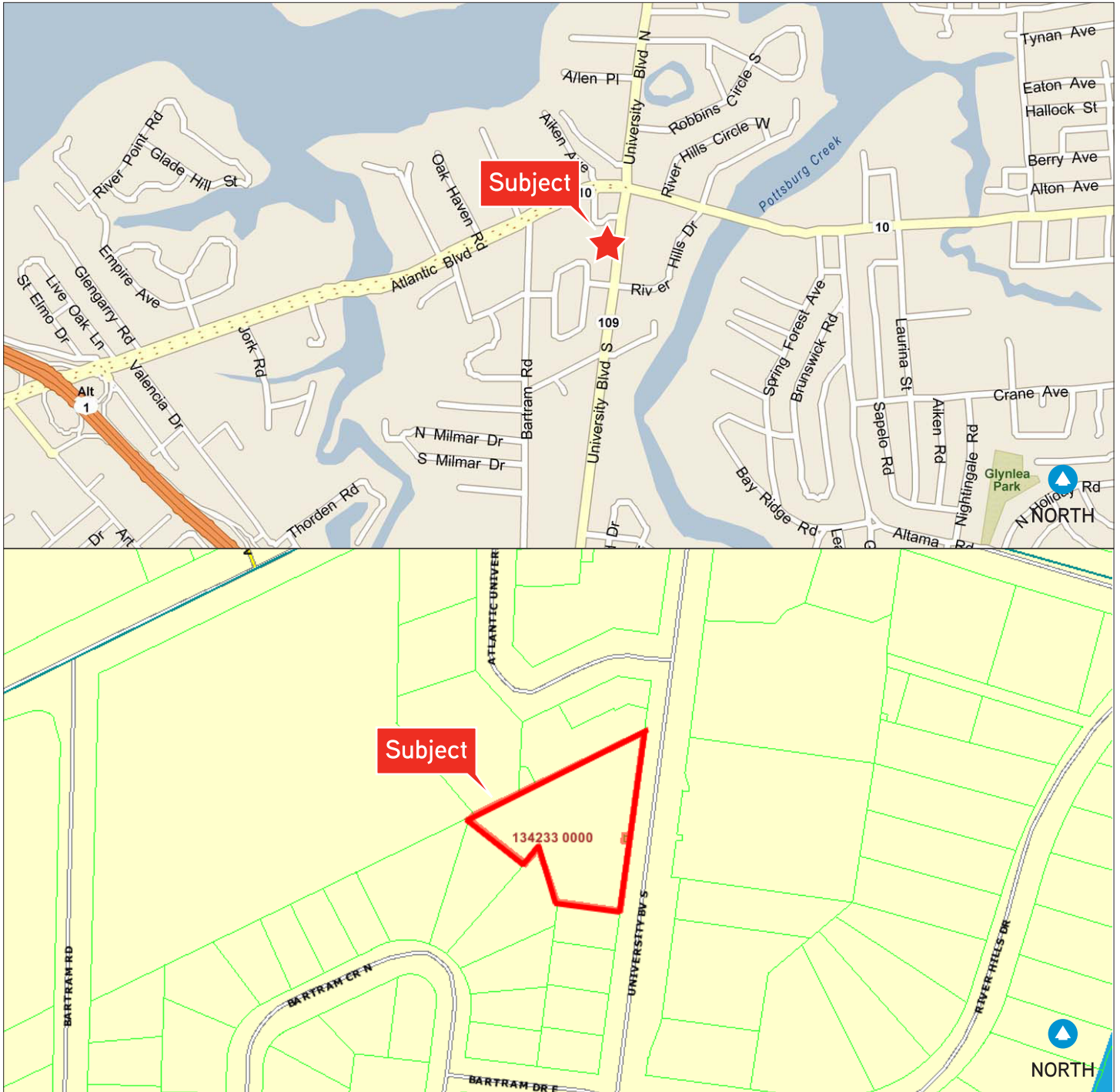

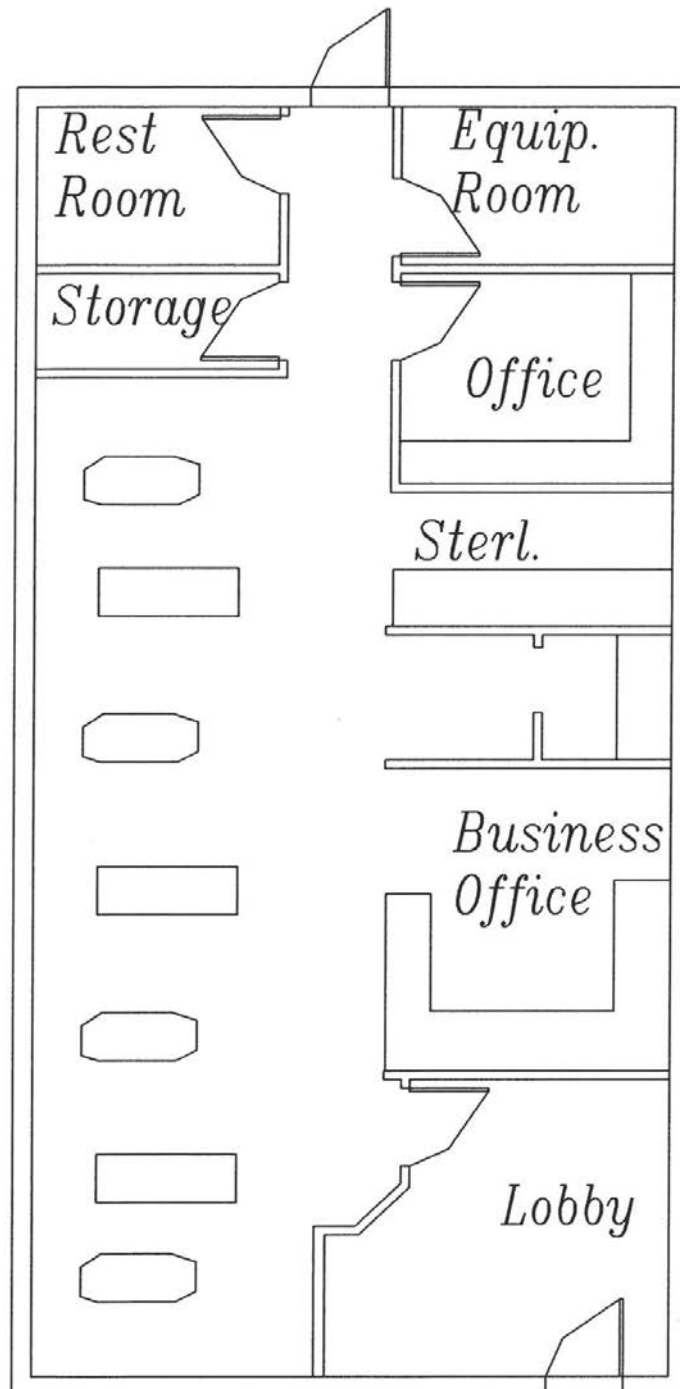
# Street & Plat Map

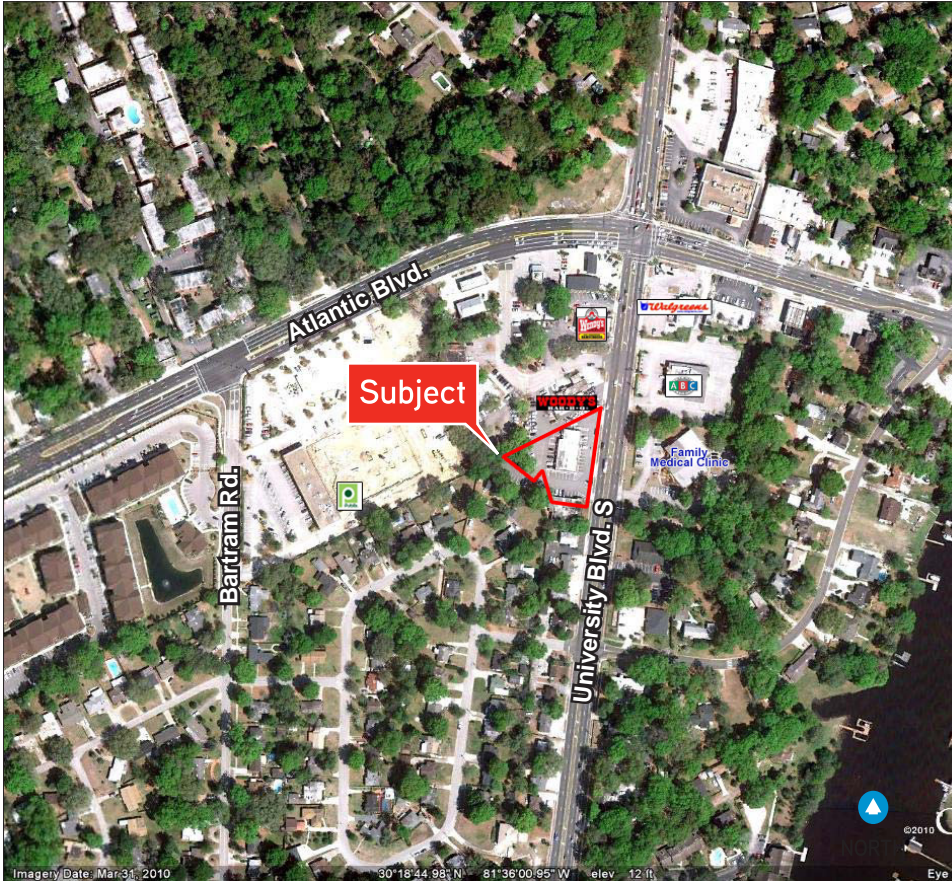
