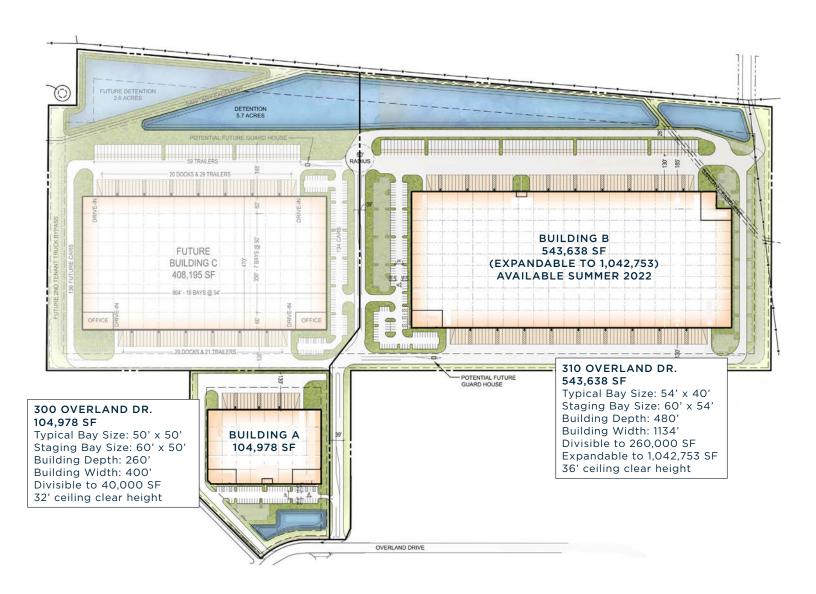

SITE PLAN

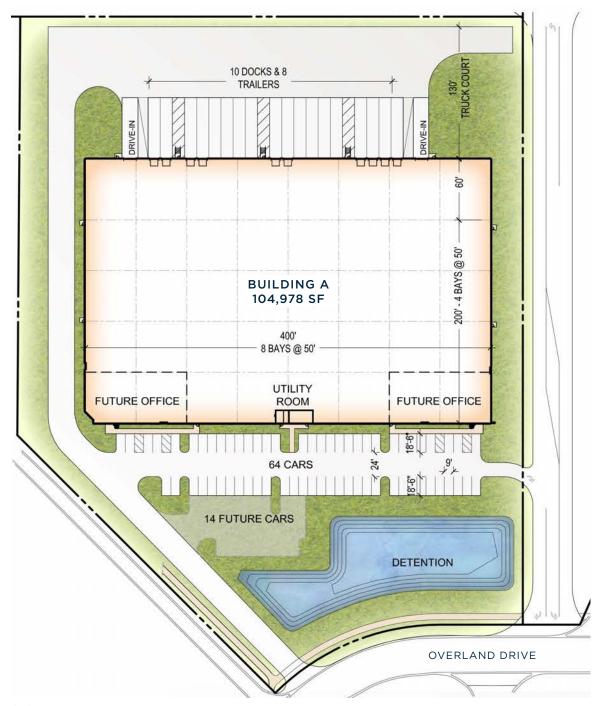

SITE PLAN - 300 OVERLAND DRIVE



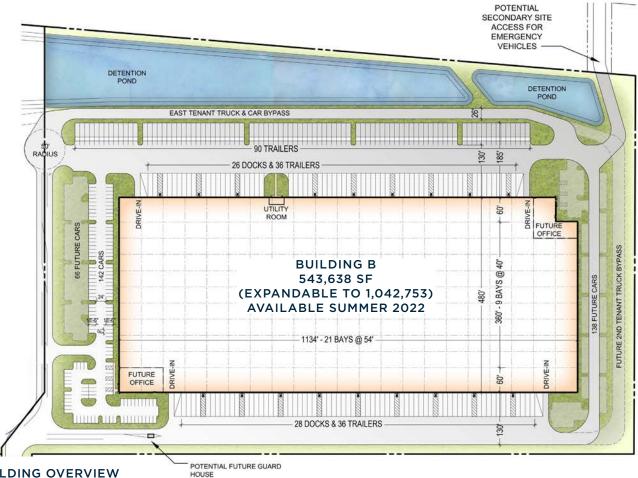

SITE PLAN - 310 OVERLAND DRIVE

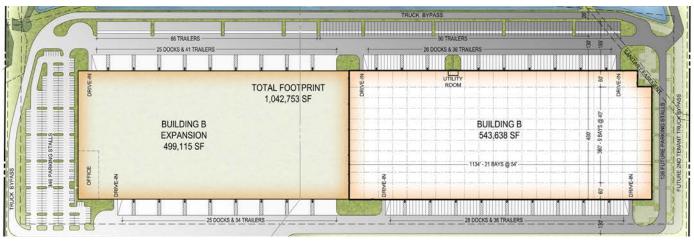

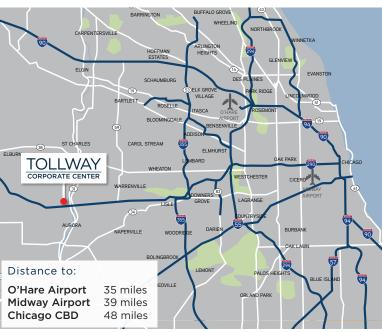
