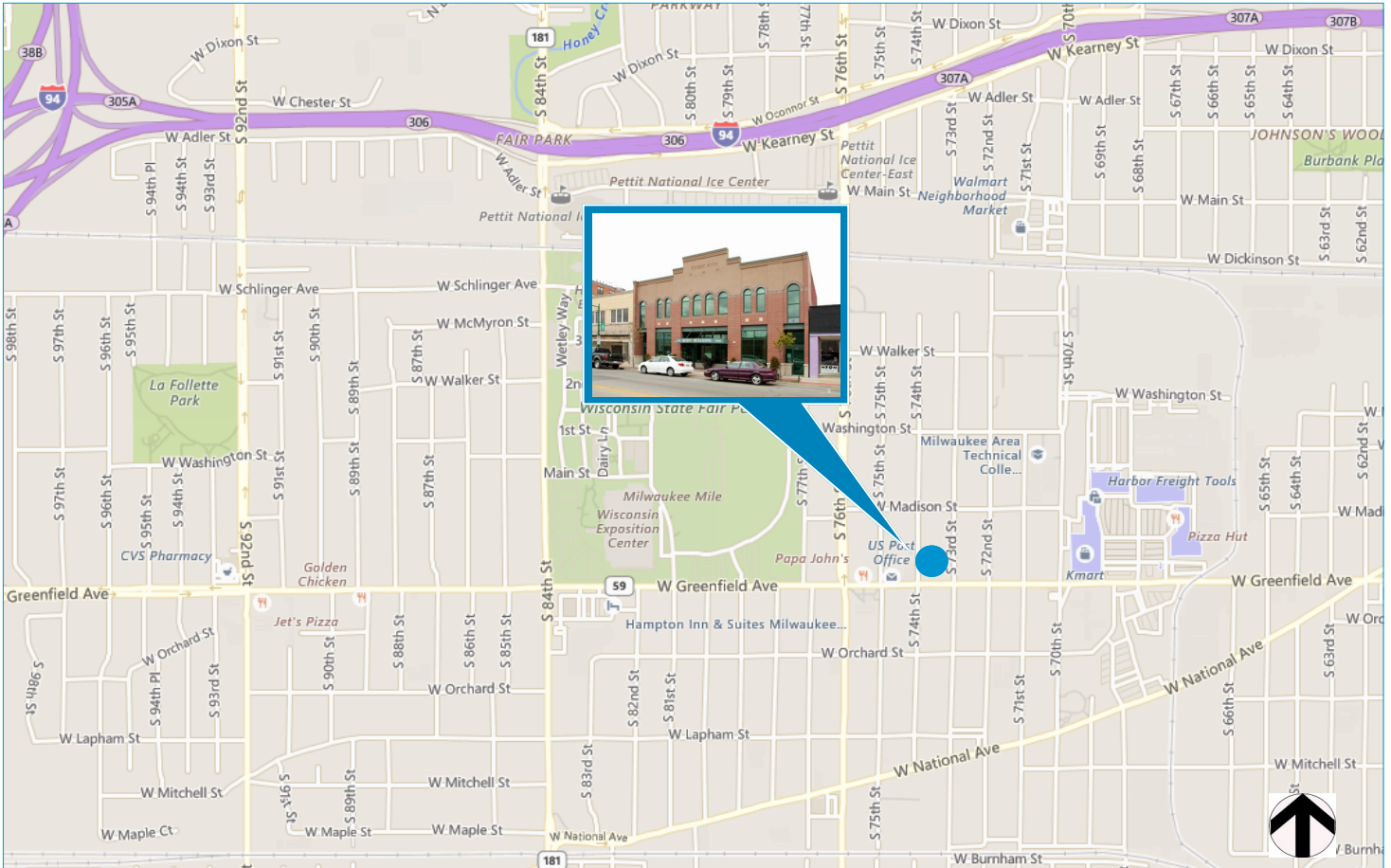

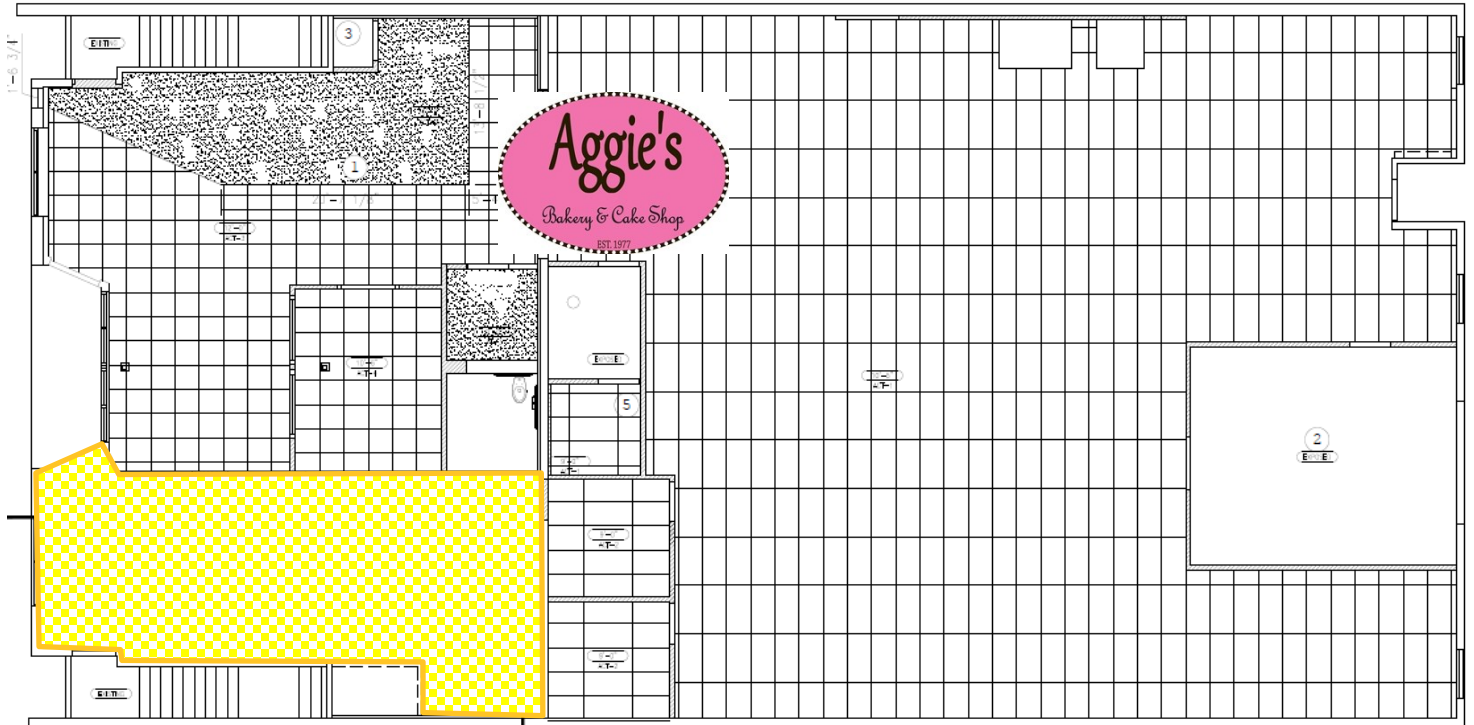

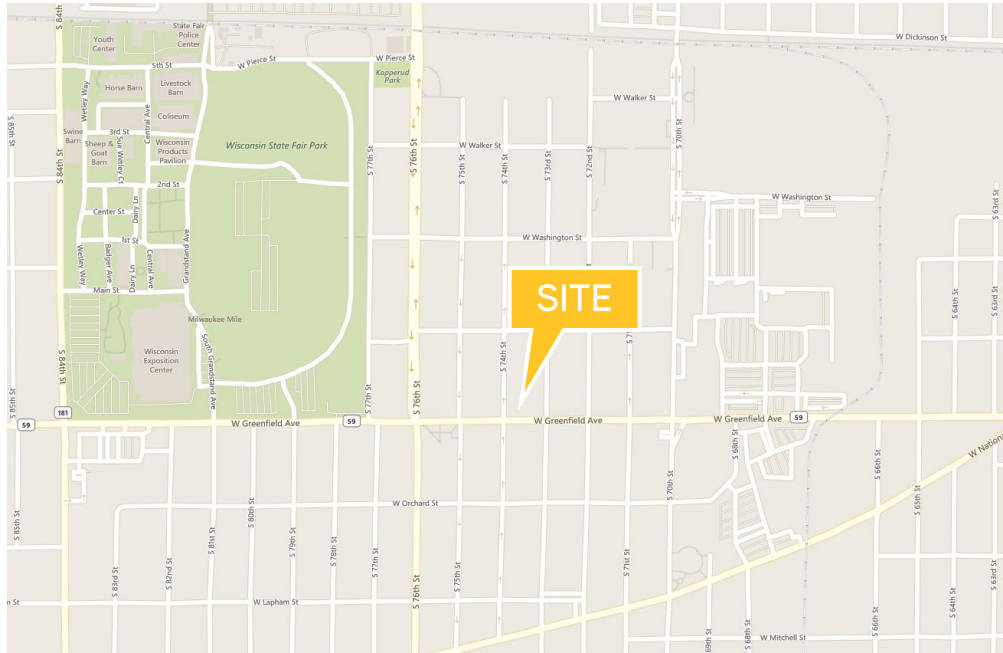
Market Aerial

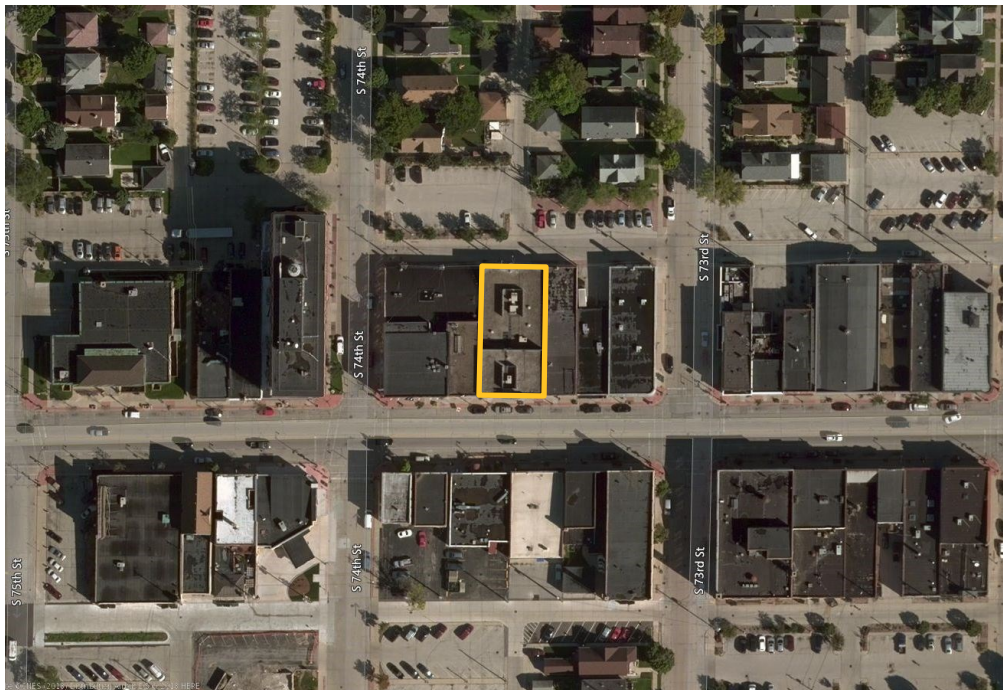
