Market Summary

CITY OF SHOW LOW OVERVIEW

Show Low was named after a poker tournament played between two of its earliest settlers. Rumor is that the players determined that there was not enough room for both of them in the community and that they would play a game of cards to decide who was to get the 100,000 acre ranch, and who had to move on. According to history it is reported that one of them stated "If you can show low, you win." The other turned up the deuce of clubs and replied "Show Low it is".

The City of Show Low, Arizona is the entrance to the White Mountains for people from both Phoenix and Tucson, and is the largest city in the White Mountain area. Show Low's major economic influence is tourism and it has become one the major second home destinations in the state. Incorporated in 1953, Show Low has a full-time population of approximately 12,000 residents which increases during the summer season to approximately 28,000 people. The average temperature of Show Low is estimated at a cool 66 degrees, with annual rainfall of around 17" per year. Show Low provides a nice reprieve for those wanting to beat the summer heat of the Phoenix and Tucson areas.

WHITE MOUNTAIN OVERVIEW

The White Mountains of Northeastern Arizona border the New Mexico border and are the second highest range of mountains in the State of Arizona. Complete with lakes and streams, the White Mountains provide residents and campers alike, plentiful fishing, four-wheeling, and with other major outdoor activities. The White Mountains has one of Arizona's largest ski areas and is prime for snowmobiling, cross-country skiing and downhill skiing at the Sunrise Ski area.

The White Mountains reach from Show Low to the Springerville-Eager area and provide a wide range of hotels and restaurants. Only 220 miles north of Phoenix and 250 miles north of Tucson, the area is a favorite for young and old alike.






