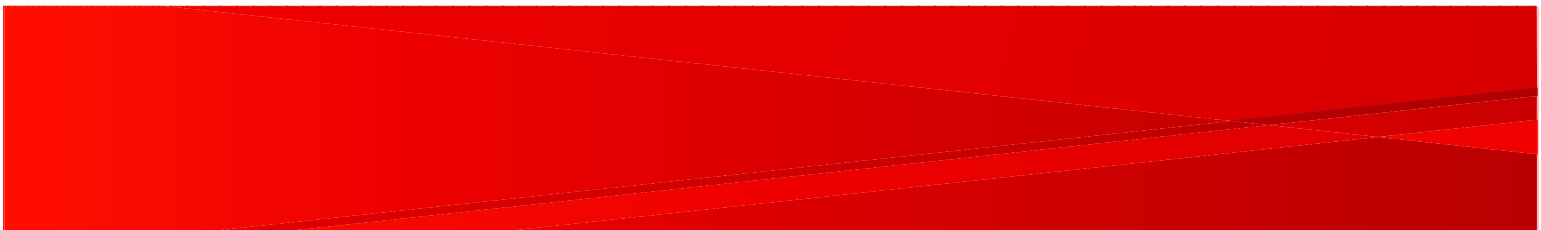

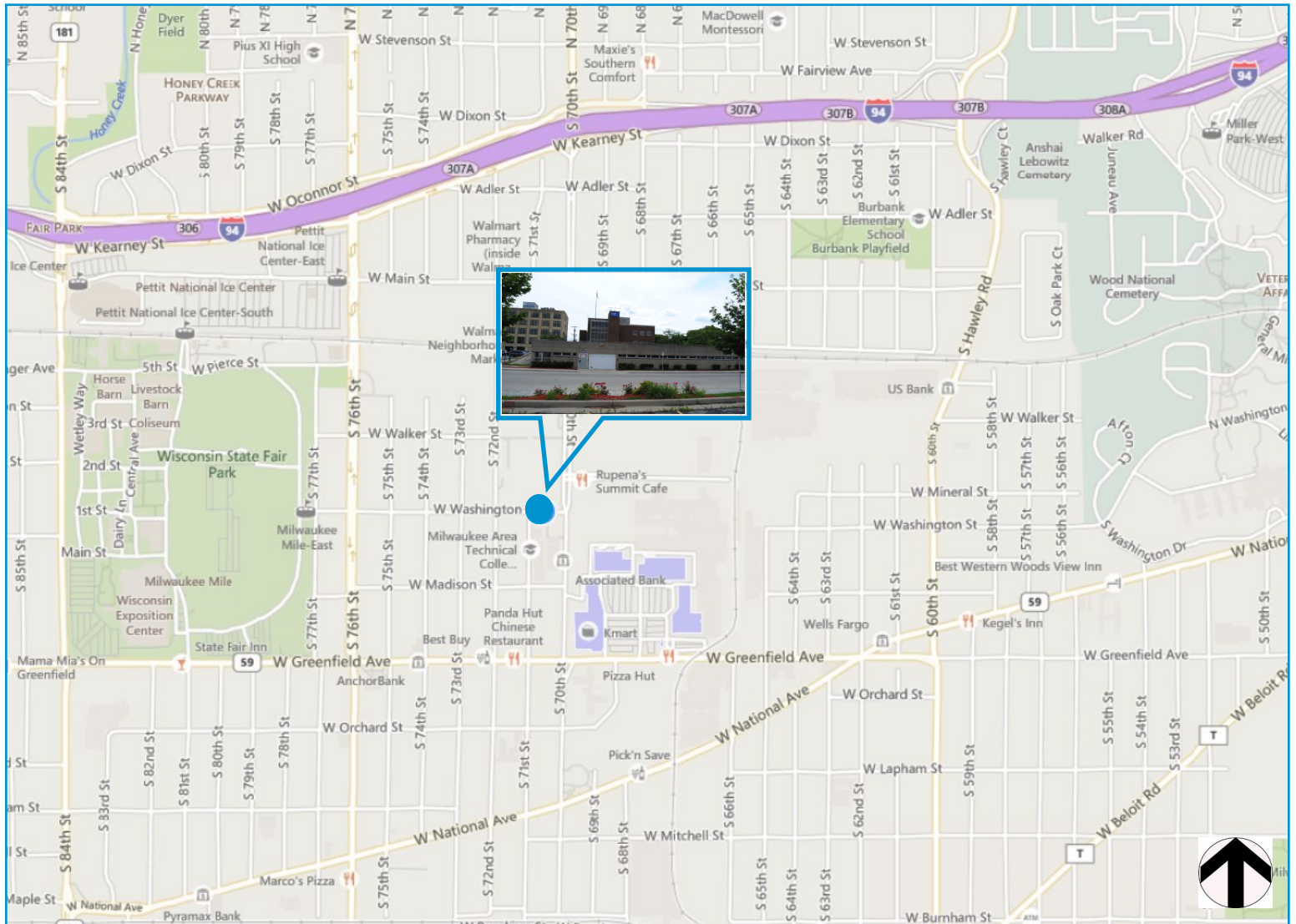

Location Map

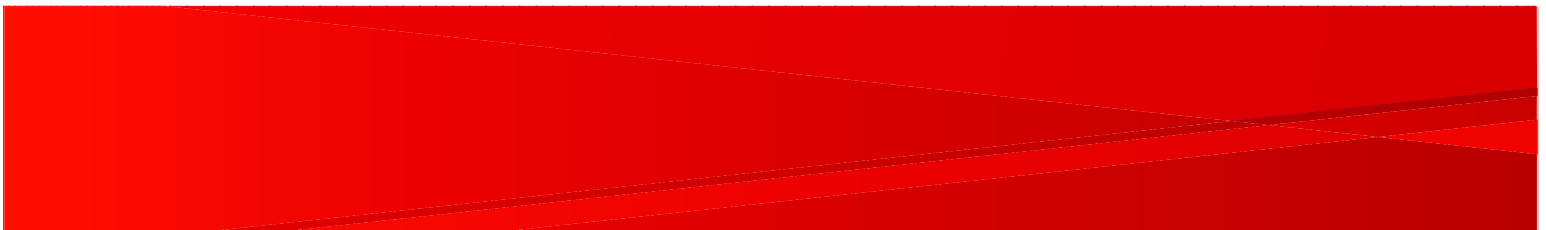
